Be it ordained by the People of the City and County of San Francisco:
Section 1. Findings
The Planning Department has determined that the actions contemplated in this Ordinance are in compliance with the California Environmental Quality Act (California Public Resources Code sections 21000 et seq.). Said determination is on file with the Clerk of the Board of Supervisors in File No. $\qquad$ and is incorporated herein by reference.

Section 2. The San Francisco Park Code is hereby amended by amending Sections 12.01, 12.02, and 12.03 to read as follows:

Sec. SEC. 12.01. CAMP MATHER CABIN AND TENT SITE USAGE FEES.
(a) The following use fees, which reflect a discount from the standard fee for nonresidential usage, shall be charged to San Francisco residents for use of cabin and tent sites at Camp Mather. The following fees do not include State occupancy tax.
