16 Section 1. Findings.

17 (a) The Planning Department has determined that the actions contemplated in this  
18 ordinance comply with the California Environmental Quality Act (Public Resources Code  
19 21000 et seq.) Said determination is on file with the Clerk of the Board of Supervisors in File  
20 No. 110626 and is incorporated herein by reference.

21 (b) In accordance with the actions contemplated herein, the Planning Commission  
22 adopted Motion No. 18351 concerning findings pursuant to the California Environmental  
23 Quality Act. Said Motion is on file with the Clerk of the Board of Supervisors in File No.  
24 110626 and the Board incorporates those findings herein by reference. Also on file with the  
25 Clerk of the Board in File No. 110626 is an Addendum prepared by the Planning

1 Department dated June 7, 2011, finding that no new significant impacts would result from a  
 2 modification to the Project analyzed in the EIR that moves the tower closest to Highway 101  
 3 one parcel to the East; the Board incorporates the findings in the Addendum herein by this  
 4 reference.

5 (c) Pursuant to Section 302 of the Planning Code, the Board finds that this  
 6 ordinance will serve the public necessity, convenience, and welfare for the reasons set forth in  
 7 Planning Commission Resolution No. 18353 and the Board incorporates those reasons herein  
 8 by reference. A copy of Planning Commission Resolution No. 18353 is on file with the Clerk  
 9 of the Board of Supervisors in File No. 110625.

10 (d) The Board of Supervisors finds that this ordinance is in conformity with the  
 11 General Plan and the Priority Policies of Planning Code Section 101.1 for the reasons set  
 12 forth in Planning Commission Resolution No. 18352 and incorporates those findings hereby  
 13 by reference.

14 (e) The Board hereby incorporates by reference the project-specific findings set  
 15 forth in Section 1(B) of the companion ordinance that amends the General Plan by amending  
 16 the Executive Park Subarea Plan of the Bayview Hunters Point Area Plan.

17 Section 2. The San Francisco Planning Code is hereby amended by amending  
 18 Sectional Map ZN10 of the Zoning Map of the City and County of San Francisco, as follows:


