3 **Ordinance authorizing settlement of the lawsuit filed by Phaedra Michelle Scott against**
4 **the City and County of San Francisco for \$40,000; the lawsuit was filed on September**
5 **27, 2021, in San Francisco Superior Court, Case No. CGC-21-595521; entitled Phaedra**
6 **Michelle Scott v. City and County of San Francisco, et al.; the lawsuit involves alleged**
7 **personal injury from tripping due to a pothole.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Phaedra Michelle Scott v. City and
12 County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-21-595521 by
13 the payment of \$40,000. The lawsuit involves alleged personal injury from tripping due to a
14 pothole.

15 Section 2. The above-named action was filed in San Francisco Superior Court on
16 September 27, 2021, and the following parties were named in the lawsuit: Plaintiff: Phaedra
17 Michelle Scott; Defendant City and County of San Francisco.
