2 **Resolution urging the Golden Gate National Recreation Area to award the renovation**  
3 **contract for the Historical Vessel THAYER to San Francisco Drydock, a union shipyard**  
4 **located in San Francisco.**

6 WHEREAS, The renovation of THAYER at a San Francisco drydock, a tenant of the  
7 Port of San Francisco located on Pier 50, would provide substantial job opportunities for  
8 union members of San Francisco; and

9 WHEREAS, San Francisco Drydock employs Bay Area residents who in turn help to  
10 boost our local economy; and

11 WHEREAS, San Francisco Drydock is a union shipyard that pays prevailing wages  
12 and fringe benefits to their workers; and

13 WHEREAS, San Francisco Drydock surpasses all competitors in performing this type  
14 of renovation as evidence from their work on the vessel EUREKA from the Historical  
15 Museum; and

16 WHEREAS, San Francisco Drydock has years of experience in the shipbuilding and  
17 repair industry; and

18 WHEREAS, San Francisco Drydock is the only company in San Francisco performing  
19 such work; and

20 WHEREAS, San Francisco Drydock has years of trade experience, employing trained  
21 union craftsmen skilled in construction and design, who have the expertise to handle the  
22 unexpected problems or emergencies that may arise during renovation; now, therefore, be it

1           RESOLVED, That the Board of Supervisors urges the Golden Gate National  
2 Recreation Area to award San Francisco Drydock a contract for the renovation of the  
3 historical vessel *THAYER*.




