AUTHORIZING

~~URGING THE BOARD OF SUPERVISORS TO AUTHORIZE~~ AN INCREASE IN ENROLLMENT

AND SERVICE LEVEL FOR CALWORKS CHILD CARE BY MODIFYING THE EXISTING CONTRACT WITH THE CHILDREN'S COUNCIL OF SAN FRANCISCO IN THE AMOUNT OF \$40.8 MILLION TO PROVIDE FOR THE INCREASE IN ENROLLMENT, PROGRAM COSTS AND A NUMBER OF CAPACITY BUILDING INITIATIVES.

WHEREAS, the California Department of Social Services (CDSS) authorized an increase in child care services as part of its general welfare reform legislation ("CalWORKs") for CalWORKs Stages I and II; and

WHEREAS, the enrollment in, and costs of, child care programs in San Francisco continue to increase; and

WHEREAS, the State of California originally allocated \$ 9 million for child care in Fiscal Year 1998-1999; and

WHEREAS, the State of California released an additional \$13 million in child care block grant funds to San Francisco on January 7, 1999; and

WHEREAS, state and federal funds constitute 91% of the funding available for child care services for this contract modification; and

WHEREAS, the Board of Supervisors of the City and County of San Francisco approved approximately \$ 2 million in child care funding for fiscal year 1998-1999; and

WHEREAS, the Children's Council of San Francisco under its existing contract, effective July 1, 1997, and continuing until June 30, 1999, for the total amount of \$13,802,435, is the largest single provider of child care services to families who are moving from welfare to work, and has provided these types of service successfully for several years; and

1 WHEREAS, the State of California approved a signed agreement between the San Francisco
2 Department of Human Services, the Children's Council of San Francisco, and Wu Yee Children's
3 Services, the three eligible California Department of Education alternative payment programs (child
4 care voucher programs), which designated CalWORKs Stage II child care services to be provided by
5 SFDHS under contract through Children's Council of San Francisco with a subcontract to Wu Yee
6 Children's Services; and

7 WHEREAS, the smooth, most seamless system for providing child care support services to
8 CalWORKs families is accomplished through the single administration of Stages I and II; and

9 WHEREAS, for purposes of efficiency, and to maximize the amount of child care that can be
10 provided to eligible participants in the funded programs, funds should be consolidated and administered
11 by Children's Council of San Francisco; and

12 WHEREAS, this contract funds direct payments to individual child care providers who cannot
13 absorb the costs of delayed payment, and the contractor does not carry a surplus to cover the increased
14 costs; and

15 WHEREAS, on January 28, 1999, the Human Services Commission will hear, and is expected
16 to approve, the modification of the agreement with the Children's Council of San Francisco, as
17 proposed herein; therefore be it

18 RESOLVED, that the Board of Supervisors of the City and County of San Francisco authorizes
19 the execution of a modification of agreement, effective retroactive to January 1, 1999, modifying the
20 contract dated July 1, 1997, with the Children's Council of San Francisco; and be it

21 FURTHER RESOLVED, that the effect of this modification of agreement shall be to increase
22 the amount and term of the contract from July 1, 1997, through June 30, 1999, from \$13,802,433, to the
23 period July 1, 1997, through June 30, 2000, to \$54,696,651; and be it

24 FURTHER RESOLVED, that the Executive Director of the Department of Human Services is
25 authorized to sign the contract for the City and County of San Francisco.


