2 Transportation Security Administration at the International Terminal.]

3 **Resolution approving retroactive to November 1, 2002, a Lease with the U.S.**  
4 **Government for office space to be occupied by the Transportation Security**  
5 **Administration at the International Terminal.**

7 WHEREAS, on November 19, 2001, the Federal government passed the Aviation and  
8 Transportation Security Act, thereby creating the Transportation Security Administration (the  
9 "TSA"); and

10 WHEREAS, the TSA is responsible for ensuring aviation security at all airports,  
11 including San Francisco International Airport; and

12 WHEREAS, the TSA has requested: 1) approximately seven thousand eight hundred  
13 six (7,806) square feet of terminal space to accommodate its administrative function, and 2)  
14 the right of first opportunity to expand in an additional 6,935 square feet of space; and

15 WHEREAS, Airport staff has negotiated a Lease with the General Services  
16 Administration with a term of five (5) years for space in the International Terminal to  
17 accommodate the TSA's administrative offices; and

18 WHEREAS, on June 25, 2003, pursuant to Resolution No. 03-0126, the Airport  
19 Commission approved the Lease with U.S. Government. A copy of the form of the Lease is  
20 on file with the Clerk of the Board of Supervisors in File No. 031170, which is hereby declared  
21 to be a part of this resolution as if set forth fully herein; now, therefore, be it

22 **RESOLVED**, that the Airport Commission hereby approves retroactive to November 1,  
23 2002, a Lease with the U. S. Government for space in the International Terminal on the terms  
24 and conditions set forth in the Director's Memorandum; and be it further


