8 WHEREAS, Charter, Section 4.137, prescribes the duties of the SDOB; and

9 WHEREAS, Charter, Section 4.137, requires that, by March 1st of each year, the
10 SDOB prepare and present to the Board of Supervisors or a committee designated by the
11 President of the Board of Supervisors, an annual report that includes a summary of SDOB
12 evaluations and outreach, and Office of the Inspector General (OIG) reports submitted to
13 SDOB, for the prior calendar year; and

14 WHEREAS, On February 2, 2024, the SDOB approved an annual report for the
15 calendar year 2023 for submission to the Board of Supervisors; and

16 WHEREAS, A copy of the SDOB's 2023 annual report, as approved by the SDOB and
17 submitted to the Board, is on file with the Clerk of the Board of Supervisors in Board File
18 No.240158; now, therefore, be it
