

1	[Commending OCEIA's Community Ambassadors Program]
2	
3	Resolution commending the Office of Civic Engagement and Immigrant Affairs
4	(OCEIA's) Community Ambassadors Program and its ambassadors for their excellence,
5	professionalism, and tireless dedication to the City and County of San Francisco.
6	
7	WHEREAS, The Community Ambassadors Program (CAP) is a community safety and
8	neighborhood engagement program of the Office of Civic Engagement and Immigrant Affairs
9	(OCEIA) that started in 2010 in the Bayview and Visitacion Valley neighborhoods in response
10	to cultural and linguistic tensions, increased violence, and the need for better community
11	safety options; and
12	WHEREAS, OCEIA's Community Ambassadors Program is the only non-police City-
13	operated ambassador program in San Francisco; and
14	WHEREAS, The Mayor's budget proposes to fund the ambassador program in
15	FY2024-2025, but to reduce funding to zero in year two of the budget, effectively ending the
16	longstanding OCEIA Community Ambassadors Program; and
17	WHEREAS, OCEIA's Community Ambassadors Program currently operates in the
18	Bayview, Visitacion Valley, Portola, Chinatown, Haight-Ashbury, Lower Haight, Hayes Valley,
19	Fillmore, Mid-Market, Tenderloin, Mission, and Outer Sunset neighborhoods; and
20	WHEREAS, CAP's community ambassadors promote multilingual community safety by
21	providing safety escorts, reporting emergencies and crime to medical and emergency
22	services, reporting hazards and street cleanliness issues, assisting merchants, helping the
23	homeless by conducting wellness checks and providing referrals for help, and informing the
24	community and visitors about the resources that the City offers; and

1 WHEREAS, In addition to hiring ambassador job positions directly, CAP is also a job 2 training program for the City & County of San Francisco in partnership with the Human 3 Services Agency (HSA) and JobsNow! to increase the number of ambassadors; and 4 WHEREAS, OCEIA's Community Ambassadors Program consists of over 60 dedicated 5 ambassadors, in addition to program and administrative staff, many of whom have served the 6 city for years; and 7 WHEREAS, OCEIA's community ambassadors are often residents of the 8 neighborhoods they serve and the teams are tailored to the linguistic needs of those 9 communities, and are often the bridge between the community and the City; and 10 WHEREAS, In FY22-23, CAP engaged in over 262,000 interactions with the 11 community, including over 55,000 merchant visits, 70,000 wellness checks, 250 crisis 12 response and interventions, including 8 lifesaving overdose responses; and

WHEREAS, OCEIA's community ambassadors receive robust trainings on violence
 prevention, de-escalation, trauma, substance use, mental health, and homelessness, are
 CPR & First Aid Certified, and are trained to administer life-saving NARCAN; and

WHEREAS, OCEIA Ambassadors work with almost every aspect of a community,
whether it's education, law enforcement, homelessness, business, maintenance, or sanitation;
and

WHEREAS, OCEIA Ambassadors are required to go through about 30 sessions of training on violence prevention, de-escalation, trauma, substance use, mental health, and homelessness, are CPR & First Aid Certified and trained to administer life-saving NARCAN; and

WHEREAS, About half of the Ambassadors are bilingual, and speak a total of eight
 different languages, and are trained to work with and talk to diverse communities to be
 25

effective at communicating either culturally or linguistically with the diverse population in the
 City; and

WHEREAS, Ambassadors must be knowledgeable about community-based
organizations, City programs and services and have extensive knowledge about where to
send people and where to refer them; and

6 WHEREAS, OCEIA provides detailed information to the public about the Community
7 Ambassador Program through its website and regular reports; now, therefore, be it

8 RESOLVED, That the San Francisco Board of Supervisors recognizes the OCEIA

9 Community Ambassadors Program as a nationally-recognized model program demonstrating

10 excellence in the field; and, be it

11 FURTHER RESOLVED, That the San Francisco Board of Supervisors applauds the

12 hardworking staff of OCEIA's Community Ambassadors Program and its ambassadors for

13 their excellence, professionalism, and tireless dedication to the City and County of San

14 Francisco; and, be it

FURTHER RESOLVED, That the San Francisco Board of Supervisors supports the
 ongoing operation of OCEIA's Community Ambassadors Program without interruption within
 the City and County of San Francisco; and, be it
