FURTHER RESOLVED, That the term of this lease shall begin on July 1, 2001, and continue for a period of TEN (10) years ending June 30, 2011; and,

FURTHER RESOLVED, That between March 1, 2006 and June 30, 2006, the Landlord shall repaint all of the interior walls of the Premises at Landlord's expense; and be it

FURTHER RESOLVED, That the base rent for the first year of the extended lease shall be \$16,500 per month (\$1.86 per square foot per month). Additional years monthly rent will be paid according to the schedule below:
