3 Ordinance authorizing settlement of the portion of the lawsuit filed by Linda Ho against
4 the City and County of San Francisco for \$88,000; the lawsuit was filed on January 31,
5 2005, in San Francisco Superior Court, Case No. 436930; entitled Jane Martin, et al. v.
6 City and County of San Francisco, et al.

7 Be it ordained by the People of the City and County of San Francisco:

8 Section 1. The City Attorney is hereby authorized to settle the portion of the action
9 entitled "Jane Martin, et al. v. City and County of San Francisco, et al." San Francisco
10 Superior Court, Court No. 436930, as it relates only to plaintiff Linda Ho, by the payment of
11 \$88,000, and excluding the claim by this plaintiff for attorney's fees, costs and interest, which
12 will be addressed in later proceedings.

13 Section 2. The above-named action was filed in San Francisco Superior Court on
14 January 31, 2005, and the following settling parties were named in the lawsuit: Plaintiff Linda
15 Ho and Defendant City and County of San Francisco.
