
1 APPROVING FINAL MAP OF 971 HOWARD STREET, A LIVE/WORK CONDOMINIUM

9 Howard Street, A Live/Work Condominium Project."


10 FURTHER MOVED, That the San Francisco Board of Supervisors adopts as its own and


