3 **Resolution in recognition and appreciation of James Loyce Jr. upon his retirement**  
4 **from service to the City & County of San Francisco, and declaring May 23, 2007 James**  
5 **Loyce Jr. day in San Francisco**

7 WHEREAS, James Loyce Jr. has served the City and County of San Francisco with  
8 distinction for over 20 years; and

9 WHEREAS, his tenure with the City has successfully spanned the reign of five Mayor's  
10 and four Health Directors; and

11 WHEREAS, in his early years with the Department "Jimmy" made a significant  
12 contribution to the field of substance abuse services seeking grants totaling more than \$20  
13 million and advocating for sobriety and recovery; and

14 WHEREAS, for 3 years in the early 90's Mr. Loyce served as the Associate Director of  
15 the AIDS Office, and for the past 9 years as Deputy Director of Health and Director of the  
16 AIDS Office providing leadership for HIV/AIDS policy, treatment and health services in a City  
17 that has born a disproportionate burden of this disease; and

18 WHEREAS, from 1994 – 1998 Mr. Loyce left CCSF employment to serve as CEO of  
19 AIDS Project Los Angeles, where he oversaw the work of the nation's second largest  
20 community support organization for persons affected by HIV/AIDS; and

21 WHEREAS, when Mr. Loyce returned to DPH in 1998 he presided over the  
22 Departments efforts to integrate services and is committed to promoting seamless access to  
23 services for special populations; and

6 policy; and

9 his family; now therefore be it


