

1 [Grant Agreement Amendment - Self-Help for the Elderly - Congregate Nutrition Services for  
2 Older Adults - Not to Exceed \$10,665,010]

3 **Resolution approving an amendment to the grant agreement between the City and**  
4 **County of San Francisco and the non-profit Self-Help for the Elderly, for the**  
5 **administration of the Congregate Nutrition Services for Older Adults Program, to**  
6 **increase the grant amount by \$1,150,820 for a total not to exceed amount of**  
7 **\$10,665,010 to commence following Board approval, with no change to the grant period**  
8 **of July 1, 2021, through June 30, 2025.**

10 WHEREAS, The City and County of San Francisco, by and through its Human Services  
11 Agency, wishes to administer the Congregate Nutrition Services for Older Adults program to  
12 reduce hunger, food insecurity, and malnutrition of older adults living in the community as well  
13 as support their safety and independence; and

14 WHEREAS, The Human Services Agency conducted a Request for Proposals #920 for  
15 this service in March 2021; and

16 WHEREAS, Self-Help for the Elderly submitted a proposal, and was awarded the grant  
17 for the total amount of \$9,514,190 for the period of July 1, 2021, through June 30, 2025; and

18 WHEREAS, The Department of Disability and Aging Services Commission approved  
19 the Congregate Nutrition Services for Older Adults grant with Self-Help for the Elderly at its  
20 meeting on July 7, 2021; and

21 WHEREAS, The Human Services Agency entered into a grant agreement with Self-  
22 Help for the Elderly for the period from July 1, 2021, to June 30, 2025, for a total not to exceed  
23 amount of \$9,514,190; and

1           WHEREAS, Charter, Section 9.118(b) provides that agreements entered into by a  
2 department requiring expenditures exceeding ten million dollars shall be subject to approval  
3 by the Board of Supervisors; and

4           WHEREAS, The City and County of San Francisco, wishes to amend the grant  
5 agreement with Self-Help for the Elderly to increase the grant amount by \$1,150,820 for a  
6 revised not to exceed amount of \$10,665,010 during the period of July 1, 2021 to June 30,  
7 2025; and

8           WHEREAS, The Department of Disability and Aging Services Commission approved  
9 the first amendment to the grant agreement with Self-Help for the Elderly for Congregate  
10 Nutrition Services for Older Adults at its meeting on April 6, 2022; now, therefore, be it

11           RESOLVED, That the Board of Supervisors hereby authorizes the amendment to the  
12 grant agreement between the City and County of San Francisco and Self-Help for the Elderly  
13 to provide the Congregate Nutrition Services for Older Adults program during the period of  
14 July 1, 2021, to June 30, 2025, for a total not to exceed amount of \$10,665,010; and, be it

15           FURTHER RESOLVED, That within thirty (30) days of the modification being fully  
16 executed by all parties, the Human Services Agency shall provide the final grant agreement to  
17 the Clerk of the Board for inclusion into the official file.
