

1 [Appointments – SRO Task Force]

3 **Motion appointing Joshua Vining and Pratibha Tekkey, terms ending December 31,**  
4 **2012, to the SRO Task Force, residency requirement waived.**

5

6 MOVED, That the Board of Supervisors of the City and County of San Francisco does  
7 hereby appoint the hereinafter designated persons to serve as members of the SRO Task  
8 Force, pursuant to the provisions of Resolution 459-06 and Resolution 457-09, for the terms  
9 specified:

10 Joshua Vining, seat 5 (residency requirement waived), succeeding Jorge Portillo,  
11 resigned, must be a representative of the Mission SRO Collaborative, for the unexpired  
12 portion of a three-year term ending December 31, 2012.

13 Pratibha Tekkey, seat 6 (residency requirement waived), succeeding Jeffrey Buckley,  
14 resigned, must be a representative of the Central City SRO Collaborative, for the unexpired  
15 portion of a three-year term ending December 31, 2012.

16 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 17 1. The membership of the SRO Task Force has a goal to be representative of the  
18 diversity of the City and County of San Francisco.
- 19 2. Applicants Joshua Vining and Pratibha Tekkey, new appointees, who are not  
20 residents of San Francisco, are persons with experience that uniquely qualifies  
21 them to serve on the SRO Task Force.
- 22 3. The SRO Task Force has attempted to fill the position, for which Joshua Vining and  
23 Pratibha Tekkey were nominated, with individuals who are City residents and who  
24 have the specific experience, skills, and qualifications, but has been unable to do so

1 at this time. The Rules Committee has certified that Joshua Vining and Pratibha  
2 Tekkey are qualified to serve on the SRO Task Force.

- 3 4. After exercising due diligence, the Board of Supervisors concludes that there are no  
4 other possible representative, who are residents of San Francisco and who have  
5 the specific experience, skills, or qualifications possessed by these applicants, and  
6 who are willing to serve on the SRO Task Force at this time; and, be it

7 FURTHER MOVED, That the Board of Supervisors waives the residency requirement  
8 for Joshua Vining and Pratibha Tekkey, as allowed in cases where no qualified City residents,  
9 willing to serve, can be found, pursuant to Section 4.101 of the City Charter that requires  
10 person(s) appointed to boards, commissions, and advisory bodies established by legislative  
11 act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.
