Be it ordained by the People of the City and County of San Francisco:

Section 1. Environmental Findings.

The Planning Department has determined that the actions contemplated in this ordinance comply with the California Environmental Quality Act (California Public Resources Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of Supervisors in File No. <u>251082</u> and is incorporated herein by reference. The Board affirms this determination.

Section 2. Chapter 94B of the Administrative Code is hereby amended by revising Section 94B.4, to read as follows. Section 94B.2 is reprinted in part, for informational purposes only.

SEC. 94B.2. ENTERTAINMENT ZONE CONTROLS.

(c) All open alcoholic beverages consumed during an Entertainment Zone Event shall be purchased only from a premises located within the Entertainment Zone that is authorized under California Business and Professions Code Section 23357, 23358, or 23396, as may be amended from time to time, to permit consumers to leave the premises with open containers of alcoholic beverages for consumption off the premises, or an organization that is authorized by an ABC special event permit or license to make such sales within the Entertainment Zone.

SEC. 94B.4. ENTERTAINMENT ZONE LOCATIONS.

(b) Additional Entertainment Zones.

(12) Fillmore Entertainment Zone.

(A) All public streets, public rights-of-way, and sidewalks abutting both sides of Fillmore Street between Sutter and McAllister Streets and O'Farrell Street between Steiner and Fillmore Streets, and all premises specified in Section 94B.2(c) that are adjacent thereto, are hereby designated as the Fillmore Entertainment Zone under Sections 23039.5 and 25690 of the California Business and Professions Code.

(B) Notwithstanding subsection (c), if an Entertainment Zone Event within the Fillmore Entertainment Zone does not involve the closure of a public street, it need not receive a permit for the use of a public street under Transportation Code Division I, Section 6.6 or 6.16 or Transportation Code Division II, Section 206, or other applicable authority of the SFMTA.

(C) Fillmore Turk Mini Park.

(i) Notwithstanding subsection (b)(12)(A) above, the Fillmore

Entertainment Zone shall not include any portion of the park known as Fillmore Turk Mini Park, located at Fillmore Street between Turk Street and Golden Gate Avenue.

(ii) To the extent there is any inconsistency between the provisions of this Chapter 94B and the provisions of the Park Code applicable to Fillmore Turk Mini Park, the Park Code shall control.

(iii) Any Management Plan for the Fillmore Entertainment Zone shall contain measures to address the impacts of entertainment zone events on Fillmore Turk Mini Park, including but not limited to alcohol consumption in and around the playground area, sanitation, and security. Before adopting such a Management Plan, OEWD shall obtain approval from the Recreation and Park Department regarding the provisions of the Management Plan that relate to impacts on Fillmore Turk Mini Park.

(c) Except as otherwise specified in this Section 94B.4, an Entertainment Zone

Event must take place in conjunction with a permit for the use of a public street under

Transportation Code Division I, Section 6.6 or 6.16 or Transportation Code Division II, Section 206, or other applicable authority of the SFMTA.

Section 3. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors intends to amend only those words, phrases, paragraphs, subsections, sections, articles, numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal

Code that are explicitly shown in this ordinance as additions, deletions, Board amendment

additions, and Board amendment deletions in accordance with the "Note" that appears under

the official title of the ordinance.

Section 4. Effective Date. This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor's veto of the ordinance.
