

5 WHEREAS, San Francisco Pedicabs, LLC, dba Golden Gate Pedicab ("Golden Gate  
6 Pedicab") is a State of California Limited Liability Corporation that operates pedicabs in San  
7 Francisco; and,

8 WHEREAS, Golden Gate Pedicab was issued License Number 14821 by the Port of  
9 San Francisco on March 25, 2010 to operate on its property; and,

10 WHEREAS, Section 39.09 of the Police Code states that permittees issued pedicab  
11 permits pursuant to the provisions of Article 39 shall file with the Board of Supervisors the  
12 fares per passenger charged for each trip; and,

13 WHEREAS, Section 39.09 further states that the Board of Supervisors may adopt,  
14 modify or reject the fare schedules submitted; and,

15 WHEREAS, Golden Gate Pedicab has filed a fare schedule with the Board of  
16 Supervisors, as required under Section 39.09 of the Police Code; and,

17 WHEREAS, Golden Gate Pedicab's proposed fare schedule, for a maximum of two  
18 passengers, is the following: \$15.00 for Pier 39 to/from Cable Cars, \$20.00 for Pier 39  
19 to/from Ghiradelli Square, \$20.00 for Pier 39 to/from the Ferry Building, \$20.00 for the  
20 ballpark to/from the Ferry Building, \$30.00 for a tour of Fisherman's Wharf, \$30.00 for a tour  
21 of Chinatown, and \$65 for a one hour tour; now, therefore be it

22 RESOLVED, that pursuant to Section 39.09 of the Police Code, the Board of  
23 Supervisors approves the fare schedule proposed by Golden Gate Pedicab.
