9 Section 1. Findings.

10 The Planning Department has determined that the actions contemplated in this
11 Ordinance are in compliance with the California Environmental Quality Act (California Public
12 Resources Code sections 21000 et seq.).

13 Section 2. The San Francisco Park Code is hereby amended by amending Section
14 12.06, to read as follows:

15 SEC. 12.06. COIT TOWER.

16 (a) The following fees shall be charged for admission to Coit Tower:

Age Category	Admission Fee
Adult	\$3.75 <u>4.50</u>
Adult with Muni Pass	\$3.00
Senior	\$2.50 <u>3.50</u>
Child (6-12 years)	\$1.50 <u>2.00</u>
Child (under 6 years)	\$0.00

23 (b) Audio tours: Upon development, and approval by the Commission, of an audio tour for
24 Coit Tower, the entrance fee for the facility shall be increased by \$1.00 to cover the cost of rental of the


