WHEREAS, The Office of the Mayor and the Glocal Youth Parliament (GYP) have invited the San Francisco Youth Commission to send two representatives to the Glocal Forum on May 22-26 In Rome, Italy; and

WHEREAS, The two Youth Commission representatives must be between 18-20 years old and include one male and one female; and

WHEREAS, The two Commissioners selected by the Youth Commission's Executive Committee are Jesse Cottrell and Joanna Gin; and

WHEREAS, This invitation includes with it an offer by the GYP to cover expenses, including flight, accommodations, and meals; and

WHEREAS, The purpose of the invitation is to provide an opportunity for the San Francisco Youth Commission representatives to meet with other Youth Leaders from around the world; and

WHEREAS, The goals outlined by the GYP include the following:

 To build and support a global network of youth from cities around the world for setting tomorrow's urban agenda and serving as a youth-led lobby in advocating this agenda locally and globally.

- 2. To forge lines of communication between youth and their Mayors, acting as a catalyst for the increased participation of young people in local government and consideration of their views among policy makers.
- To empower youth in affecting positive social change in their local communities through personal skill enhancement, access to information and global network activity.
- 4. To create a 'Vision 2020' movement as a tool for mobilizing a critical mass of youth from around the world to articulate their desires and concerns for the future as a basis for policy analysis and advocacy, and

WHEREAS, The San Francisco Youth Commission wishes to send representatives to attend the Glocal Youth Parliament in Rome on May 22-26, 2003, and continue the exchange of ideas with youth leaders from around the world; now, therefore, be it
