[Local Agency Formation Commission - Interim Administrative Officer - Clerk of the Board]

Motion authorizing the Clerk of the Board of Supervisors to accept the appointment as the Interim Administrative Officer to perform administrative duties on behalf of the San Francisco Local Agency Formation Commission, commencing upon the elimination of the 9775 Senior Community Development Specialist II position occurring through the approval of the City and County of San Francisco's FYs 2017-2018 and 2018-2019 budget, until such time as the San Francisco Local Agency Formation Commission has selected their Executive Officer.

WHEREAS, The Board of Supervisors Budget and Finance Committee recommended to eliminate the 9775 Senior Community Development Specialist II position that performs as the Executive Officer for the San Francisco Local Agency Formation Commission (SF LAFCo), through the approval of the City and County of San Francisco's FY2017-2018 budget; and

WHEREAS, On July 18, 2017, the Board of Supervisors passed on First Reading the City and County of San Francisco's FYs 2017-2018 and 2018-2019 budget, and will consider passage of the budget on Final Reading at the July 25, 2017, meeting; and

WHEREAS, Soon thereafter, the Mayor will sign and approve the FYs 2017-2018 and 2018-2019 budget and the 9775 Senior Community Development Specialist II position will be eliminated; and

WHEREAS, In anticipation of the elimination of this staff position, at the July 20, 2017, Regular Meeting of SF LAFCo, the Commission approved Resolution No. 2014-04, contained in Board of Supervisors File No. 170847, that appointed the Clerk of the Board of Supervisors as Interim Administrative Officer to perform administrative duties on behalf of SF LAFCo and

to reimburse the Office of the Clerk of the Board based upon costs presented and approved, for such duties as clerking, video streaming, archive hosting and closed captioning, accounting, budgeting, human resources, payroll, IT support and services, and risk management, while exploring various options to retain Executive Officer services; and

WHEREAS, The duties to be performed by the Clerk of the Board shall be administrative only in nature, and the Clerk will not request reimbursement from SF LAFCo on the duties performed by her position; now, therefore, be it

MOVED, That the Board of Supervisors of the City and County of San Francisco hereby authorizes the Clerk of the Board of Supervisors to accept the appointment as the Interim Administrative Officer to perform administrative duties on behalf of the San Francisco Local Agency Formation Commission, commencing upon the elimination of the 9775 Senior Community Development Specialist II position through the approval of the City and County of San Francisco's FYs 2017-2018 and 2018-2019 budget, until such time as the San Francisco Local Agency Formation Commission has selected their Executive Officer.

Resolution appointing an Interim Administrative Officer to perform administrative duties on behalf of the Local Agency Formation Commission, commencing on the last day of service of the current Executive Officer.

WHEREAS, LAFCO approved a Fiscal Year 2017-2018 budget, which included the cost of an Executive Officer provided through a City and County of San Francisco staff position approved by the Board of Supervisors in 2009; and

WHEREAS, The Budget and Finance Committee of the Board of Supervisors recommended that the Board of Supervisors eliminate the Executive Officer staff position in the 2017- 2018 City and County of San Francisco budget and the Board of Supervisors is scheduled to consider that recommendation in July 2017; and

WHEREAS, As a consequence of the actions of the Board of Supervisors, LAFCO may need to implement a process to retain an independent Executive Officer through a Request for Proposals process or other means; and

WHEREAS, LAFCO desires to appoint an Interim Administrative Officer to perform administrative functions of the Executive Directors position before the LAFCO can complete and appoint a new Executive Officer; now, therefore, be it

RESOLVED, That the Local Agency Formation Commission of the City and County of San Francisco hereby appoints the Clerk of the Board of Supervisors of the City and County of San Francisco as Interim Administrative Officer to perform administrative duties on behalf of LAFCO if the Board of Supervisors eliminates the LAFCO Executive Officer staff position. This appointment shall commence on the last day of service of the current Executive Officer.

LAFCO will reimburse the Office of the Clerk of the Board of Supervisors based upon costs presented and approved by LAFCO; and, be it

FURTHER RESOLVED, That the Local Agency Formation Commission of the City and County of San Francisco hereby directs its general legal counsel to provide written notice to LAFCo's Executive Officer that (1) if and when the City and County of San Francisco eliminates the LAFCo Executive Officer staff position, his duties with LAFCo will end, and (2) LAFCo is exploring various options for retaining Executive Officer services in the future; and, be it

FURTHER RESOLVED, That the Local Agency Formation Commission of the City and County of San Francisco hereby directs its general legal counsel to work with the Clerk of the Board of Supervisors to fulfill the administrative functions of LAFCo, should the City and County of San Francisco not authorize the Clerk of the Board of Supervisors to serve as the Interim Administrative Officer for LAFCo.
