1 [Charter Amendment - Public Advocate]

3 **Describing and setting forth a proposal to the voters, at an election to be held on**

4 **November 8, 2016, to amend the Charter of the City and County of San Francisco to:**

5 **1) create the Office of the Public Advocate; 2) set the Public Advocate’s powers and duties;**

6 **3) authorize the Public Advocate to review the administration of City programs, including**

7 **programs for transmitting information to the public, and to receive, investigate, and**

8 **attempt to resolve complaints regarding City services and programs; 4) place the Public**

9 **Advocate in charge of the Office of Labor Standards Enforcement, the Office of Citizen**

10 **Complaints, and the Controller’s whistleblower program; 5) call a special election for**

11 **November 7, 2017 to elect the first Public Advocate; 6) provide for the Public Advocate’s**

12 **election, removal, and salary; and 7) establish a set-aside of .03% of the City’s budget, as**

13 **well as the amounts previously budgeted to OLSE, OCC, and the whistleblower program,**

14 **to fund the Office of the Public Advocate, and setting an operative date.**

15

16 Section 1. The Board of Supervisors hereby submits to the qualified voters of the City

17 and County, at an election to be held on November 8, 2016, a proposal to amend the Charter of

18 the City and County by revising Sections 4.127, 6.100, 10.104, 13.101, 13.101.5, 13.102, 15.105,

19 A8.343, A8.409-1, F1.102, F1.113, and F1.114, adding Sections 6.107 and 8C.101 through

20 8C.108, and deleting Sections F1.107 and F1.108, to read as follows:

1    **SEC. 6.100. DESIGNATION OF OTHER ELECTIVE OFFICERS.**

2           In addition to the officers required to be elected under other Articles of this Charter, the  
3 following shall constitute the elective officers of the City and County: the Assessor-Recorder,  
4 City Attorney, District Attorney, Public Defender, Sheriff, ~~and~~ Treasurer, and Public Advocate.  
5 Each such officer shall be elected for a four-year term and shall serve full time.

6           The City Attorney shall be licensed to practice law in all courts of the State of California  
7 and shall have been so licensed for at least ten years next preceding his or her election. The  
8 District Attorney and Public Defender shall each be licensed to practice law in all courts of the  
9 State of California and shall have been so licensed for at least five years next preceding his or her  
10 election. Such officers shall not engage in the private practice of law during the period they  
11 serve as elective officers of the City and County.

12           Subject to the powers and duties set forth in this Charter, the officers named in this  
13 section shall have such additional powers and duties prescribed by state laws for their respective  
14 office. The terms of office in effect for these officers on the date this Charter is adopted shall  
15 continue.

16  
17    **SEC. 6.107. PUBLIC ADVOCATE.**

18           (a) There shall be a Public Advocate for the City and County of San Francisco. The  
19 functions, powers, and duties of the Public Advocate are set forth in Article VIII C.

20           (b) The Public Advocate shall appoint a Chief Deputy Public Advocate and at least two  
21 Assistant Public Advocates, who shall serve at the pleasure of the Public Advocate, and may  
22 have such other staff as provided according to the budgetary and fiscal provisions of the  
23 Charter, including Section 8C.108. The position of Chief Deputy Public Advocate shall be  
24 exempt from competitive civil service selection, appointment, and removal procedures under  
25

1 Section 10.104(2), and the position of Assistant Public Advocate shall be exempt under  
2 Section 10.104(14).

3 (c) The City Attorney shall be the attorney for the Public Advocate.

4 (d) The Public Advocate shall have an office in City Hall.

5 (e) During his or her tenure, the Public Advocate shall not contribute to, solicit  
6 contributions to, publicly endorse or oppose or urge the endorsement of or opposition to or  
7 otherwise participate in a campaign for a candidate for City elective office, other than himself or  
8 herself, or be an officer, director, or employee of or hold a policy-making position in an  
9 organization that makes political endorsements regarding candidates for City elective office.

10  
11 **ARTICLE VIIIIC: OFFICE OF THE PUBLIC ADVOCATE**

12 **SEC. 8C.101. PUBLIC ADVOCATE—GENERAL POWERS AND DUTIES.**

13 (a) Access to City Records. Except as provided below, the Public Advocate shall have  
14 timely access to all records in the possession of City officers and agencies that the Public  
15 Advocate deems necessary to complete the investigations, inquiries, and reviews required of him  
16 or her by the Charter or other City law, and if necessary may issue subpoenas to enforce his or  
17 her right of access to such records. The Public Advocate shall not have a right of access to  
18 records the disclosure of which is forbidden by state or federal law, or records protected from  
19 disclosure by privileges under federal, state, or local law, or other confidentiality provisions the  
20 existence of which is derived from some source of state law other than the Public Records Act,  
21 including, but not limited to, criminal investigation and prosecution files. The Public Advocate  
22 may not disclose records that the City officer or agency possessing the records may decline to  
23 disclose under the Public Records Act and the Sunshine Ordinance, as amended, or any  
24 successor legislation, if the officer or agency declines to disclose such records.

1           *(b) Access to Third-Party Witnesses and Records. In performing his or her duties, the*  
2 *Public Advocate may administer oaths, take testimony, and, if necessary to complete the*  
3 *investigations, inquiries, and reviews required of him or her by the Charter, issue subpoenas to*  
4 *require witnesses to appear and produce evidence. The Public Advocate may seek enforcement*  
5 *of such subpoenas in the manner prescribed by law.*

6           *(c) Introduce Legislation. The Public Advocate may introduce legislation at the Board*  
7 *of Supervisors to address any matter within the Public Advocate's jurisdiction. The Public*  
8 *Advocate may not introduce legislation addressing specific contract or personnel decisions*  
9 *unless those contracts or personnel decisions involve the Public Advocate's office.*

10           *(d) Non-Interference. The Public Advocate shall not have any power or authority over,*  
11 *nor shall the Public Advocate dictate, suggest or interfere with any appointment, promotion,*  
12 *compensation, disciplinary action, contract or requisition for purchase or other administrative*  
13 *actions or recommendations of an elected official, the Controller, or the City Administrator, or*  
14 *of department heads under the Mayor, the City Administrator or under a board or*  
15 *commission. The Public Advocate shall not have any power or authority over, nor shall the*  
16 *Public Advocate dictate, suggest, or interfere with, any criminal investigation or prosecution.*

17           *(e) Hearings. The Public Advocate may hold public hearings in the course of fulfilling*  
18 *the requirements of this Article VIIC.*

19           *(f) Confidentiality of Records. The Public Advocate may, to the extent permitted by*  
20 *state law, designate the records of any investigation, including but not limited to information that*  
21 *would reveal the identity of complainants and witnesses, as confidential information. It shall be*  
22 *official misconduct for any person to disclose information about any such investigation, except*  
23 *as necessary to conduct the investigation, or with proper authorization, or as required by law or*  
24 *lawful process. The Public Advocate may disclose confidential information to the District*  
25 *Attorney to initiate or assist in a criminal investigation or prosecution. The unauthorized*

1 release of confidential information shall be sufficient grounds for the termination of any  
2 employee.

3 (g) Reports. The Public Advocate may issue reports relating to the operations or  
4 activities of any City officer or agency, including recommendations for administrative or  
5 legislative changes. The Public Advocate may, to the extent permitted by state law, designate  
6 any portion of any draft, preliminary, or final report as confidential information. Before making  
7 public any portion of any draft, preliminary, or final report, the Public Advocate shall send a  
8 copy of the draft report to any officer, and to the head of any agency, discussed in such report  
9 and provide the officer and agency, in writing, with a reasonable deadline for their review and  
10 response. The Public Advocate shall include in any report, or portion thereof, that is made  
11 public a copy of all such officer and agency responses, after redacting any information  
12 contained in such responses that is confidential under state law.

13 (h) Annual Report. Not later than December 1 of each year, the Public Advocate shall  
14 present to the Board of Supervisors, the Mayor, the City Administrator, and the Controller a  
15 report on the activities of the office during the preceding fiscal year. The report shall include:

16 (1) A statistical summary of the complaints received during such fiscal year,  
17 categorized by agency, type of complaint, agency response, mode of resolution, and such other  
18 factors as the Public Advocate deems appropriate;

19 (2) An analysis of recurring complaints and complaints raising systemic or  
20 citywide issues and the Public Advocate's recommendations for administrative, legislative, or  
21 budgetary actions to resolve the underlying problems causing the complaints;

22 (3) A summary of the findings and recommendations of the agency program  
23 reviews conducted during the fiscal year and a summary of each agency's responses to such  
24 findings and recommendations; and

25 (4) Legislative proposals to improve the provision of City services and programs.

1           The Controller shall prepare and the Public Advocate shall include in this report an  
2 assessment of the fiscal implications of any recommendations presented in the report.

3           (i) **Outside Experts.** Notwithstanding any other provision of this Charter or any  
4 ordinance or regulation of the City, the Public Advocate may contract with outside, independent  
5 experts to assist in performing the requirements of this Article VIIC. In doing so, the Public  
6 Advocate shall make good faith efforts to comply with the provisions of Chapters 12 et seq. of the  
7 Administrative Code, as amended, or any successor legislation, but shall not be subject to the  
8 approval processes of other City agencies. The Public Advocate shall submit an annual report  
9 to the Board of Supervisors summarizing any contracts issued pursuant to this Section and  
10 discussing the Public Advocate's compliance with Chapters 12 et seq. Contracts issued by the  
11 Public Advocate pursuant to this Section shall be subject, to the requirements of Sections 6.102  
12 and 9.118.

13           No outside expert or firm shall be eligible to participate or assist in an audit or  
14 investigation of any issue, matter, or question as to which that expert or firm has previously  
15 rendered compensated advice or services to any individual, corporation, or other entity, or City  
16 official or department. The Public Advocate shall adopt appropriate written regulations  
17 implementing this prohibition, and shall incorporate this requirement in all written contracts  
18 with outside experts and firms utilized pursuant to this subsection (i).

19  
20 **SEC. 8C.102. PUBLIC ADVOCATE—REVIEW OF CITY PROGRAMS.**

21           (a) The Public Advocate may review the administration of City programs by City  
22 agencies. Such reviews may include, but not be limited to, evaluations of (1) the distribution of  
23 City programs and services throughout the City; (2) the effectiveness of the public information  
24 and service complaint programs of City agencies; and (3) the responsiveness of City agencies to  
25 individual and group requests for data or information regarding the agencies' structure,

1 activities, and operations. The Public Advocate shall submit any reports documenting or  
2 summarizing such reviews to the Board of Supervisors, the Mayor, and the appropriate agency,  
3 and shall include in such reports his or her recommendations for addressing the problems  
4 identified and the fiscal implications of such recommendations.

5 (b) The Public Advocate may review the management and employment practices of City  
6 officers and departments, including City policies and MOU provisions, that promote or impede  
7 the effective and efficient operation of City government, including management of workers'  
8 compensation claims and overtime expenditures.

9 (c) The Public Advocate may review the City's contracting procedures and compliance  
10 with contracting rules and standards.

11 (d) The Public Advocate may conduct performance audits of City departments, services,  
12 programs, and other activities. Nothing in this Section 8C.102 shall affect the powers or duties  
13 of the Controller acting as City Services Auditor under Charter Section F1.104, and the Public  
14 Advocate may coordinate with the City Services Auditor when both officers decide to conduct a  
15 performance audit of the same City department, service, program, or activity.

16  
17 **SEC. 8C.103. PUBLIC ADVOCATE—INDIVIDUAL COMPLAINTS.**

18 (a) The Public Advocate may receive, investigate, and attempt to resolve complaints  
19 from members of the public concerning City services, programs, or activities, except for those  
20 that:

21 (1) another City agency is required by law to adjudicate;

22 (2) may be resolved through a grievance mechanism established by collective  
23 bargaining agreement or contract; or,

24 (3) involve allegations of conduct that may constitute a violation of criminal law.  
25



1 If the Public Advocate receives a complaint that involves conduct of a City employee that could  
2 lead to discipline, the Public Advocate shall consult with the Department of Human Resources.

3 If the Public Advocate receives a complaint that is subject to a procedure described in items (1)  
4 or (2) of this subsection (a), the Public Advocate shall advise the complainant of the appropriate  
5 procedure for the resolution of such complaint. If the Public Advocate receives a complaint of  
6 the type described in item (3) of this subsection, the Public Advocate shall promptly refer the  
7 matter in accordance with subsection (c).

8 (b) The Public Advocate shall establish procedures for receiving and processing  
9 complaints, responding to complainants, conducting investigations, and reporting findings, and  
10 shall inform the public about such procedures. Upon an initial determination that a complaint  
11 may be valid or that the Public Advocate is not in a position to judge whether it may be valid, the  
12 Public Advocate shall refer the complaint to the appropriate agency for resolution. If such  
13 agency does not resolve the complaint in a manner that is satisfactory to the Public Advocate  
14 within a reasonable time, the Public Advocate may conduct an investigation and make specific  
15 recommendations to the agency for resolution of the complaint. If, within a reasonable time  
16 after the Public Advocate has completed an investigation and submitted recommendations to the  
17 agency, such agency has failed to respond to the recommendations in a manner that is  
18 satisfactory to the Public Advocate, the Public Advocate may issue a report to the Board of  
19 Supervisors, the Mayor, and the agency. Such report shall describe the conclusions of the  
20 investigation and make such recommendations for administrative, legislative, or budgetary  
21 action, together with their fiscal implications, as the Public Advocate deems necessary to resolve  
22 the complaint or to address the underlying problems discovered in the investigation. In  
23 exercising its functions under this subsection (b), the Public Advocate may treat related  
24 complaints together.

1           (c) If the Public Advocate receives a complaint alleging conduct that may constitute a  
2 violation of conflict of interest or governmental ethics laws, he or she shall promptly refer the  
3 complaint to the Ethics Commission and the City Attorney. If the Public Advocate receives a  
4 complaint alleging conduct that may constitute a violation of criminal law, he or she shall  
5 promptly refer the complaint and information in his or her possession regarding the alleged  
6 violation to the District Attorney.

7           If during the conduct of any investigation, inquiry, or review authorized by this section,  
8 the Public Advocate discovers that the matter involves conduct that may constitute a violation of  
9 conflict of interest or governmental ethics laws, he or she shall take no further action but shall  
10 promptly refer the matter to the Ethics Commission and the City Attorney. If during the conduct  
11 of any investigation, inquiry, or review authorized by this section, the Public Advocate discovers  
12 that the matter involves conduct that may constitute a violation of criminal law, he or she shall  
13 take no further action but shall promptly refer the matter and information in his or her  
14 possession to the District Attorney.

15           Before making a determination whether alleged conduct may constitute a violation of  
16 conflict of interest or governmental ethics laws, the Public Advocate shall consult with the City  
17 Attorney. Before making a determination whether alleged conduct may constitute a violation of  
18 criminal law, the Public Advocate shall consult with the District Attorney.

19  
20 **SEC. 8C.104. PUBLIC ADVOCATE—OFFICE OF LABOR STANDARDS**  
21 **ENFORCEMENT.**

22           (a) There shall be an Office of Labor Standards Enforcement (OLSE) within the Office of  
23 the Public Advocate. The Public Advocate shall have the power and duty to organize,  
24 reorganize, and manage the OLSE.

1           (b) The OLSE shall enforce the City's laws relating to labor and employment standards,  
2 and shall carry out any additional duties and functions, as assigned by Charter or ordinance,  
3 either now or in the future. The OLSE may enforce the provisions of the California Labor Code  
4 to the extent permitted by State law.

5           (c) The OLSE may impose penalties and take any and all appropriate action to enforce  
6 City laws within its jurisdiction, and to the extent permitted by State law, the Labor Code  
7 provisions that City law requires or permits the OLSE to enforce.

8           (d) The OLSE shall be administered by the Labor Standards Enforcement Officer, who  
9 shall be appointed by, and shall serve at the pleasure of, the Public Advocate. In appointing the  
10 Labor Standards Enforcement Officer, the Public Advocate shall consider, among other relevant  
11 factors, the individual's experience enforcing labor standards. The Labor Standards  
12 Enforcement Officer shall coordinate his or her activities with federal and State labor standards  
13 agencies, as appropriate.

14           (e) All City departments shall cooperate with the OLSE in the exercise of its functions  
15 and duties.

16           (f) The Labor Standards Enforcement Officer shall have the authority to subpoena the  
17 production of books, papers, records, or other items relevant to investigations under the  
18 jurisdiction of the OLSE.

19           (g) If the OLSE, upon the receipt of a complaint from any person or on its own initiative,  
20 has reason to believe that there is or has been a violation of any law that the OLSE is  
21 responsible for enforcing, the OLSE immediately shall forward the complaint and/or information  
22 in its possession regarding the alleged violation to the City Attorney. Within 10 working days  
23 after receipt of the complaint or information, the City Attorney shall inform the OLSE in writing  
24 regarding whether the City Attorney has initiated or intends to pursue an investigation of the  
25 matter. The OLSE may initiate its own investigation during this 10-day period. If the City

1 Attorney informs the OLSE in writing that the City Attorney will pursue the case, the OLSE shall  
2 suspend its own investigation.

3  
4 **SEC. 8C.105. PUBLIC ADVOCATE—WHISTLEBLOWERS.**

5 (a) The Public Advocate shall have the authority to receive complaints by members of  
6 the public concerning wasteful and inefficient City government practices, misuse of City  
7 government funds, and improper activities by City government officers, employees, and  
8 contractors. The Public Advocate shall investigate and otherwise attempt to resolve such  
9 individual complaints except for those that:

10 (1) another City agency is required by federal, state, or local law to adjudicate,

11 (2) may be resolved through a grievance mechanism established by collective  
12 bargaining agreement or contract,

13 (3) involve allegations of conduct that may constitute a violation of criminal law,

14 or

15 (4) are subject to an investigation by the District Attorney, the City Attorney, or  
16 the Ethics Commission, where either official or the Commission states in writing that  
17 investigation by the Public Advocate would substantially impede or delay his, her, or its own  
18 investigation of the matter.

19 If the Public Advocate receives a complaint described in items (1), (2), (3), or (4) of this  
20 subsection (a), the Public Advocate shall advise the complainant of the appropriate procedure  
21 for the resolution of such complaint.

22 (b) If the Public Advocate receives a complaint alleging conduct that may constitute a  
23 conflict of interest or governmental ethics law, he or she shall promptly refer the complaint to  
24 the Ethics Commission and the City Attorney. If the Public Advocate receives a complaint  
25 alleging conduct that may constitute a violation of criminal law, he or she shall promptly refer

1 the complaint and information regarding the alleged violation to the District Attorney. Nothing  
2 in this Section 8C.105 shall preclude the Public Advocate from investigating whether any alleged  
3 criminal conduct also violates any civil or administrative law, statute, ordinance, resolution, or  
4 regulation.

5 Within 10 working days after receipt of the complaint and information, the City Attorney  
6 or the District Attorney shall inform the Public Advocate in writing regarding whether either  
7 office has initiated or intends to pursue an investigation of the matter. If either office informs the  
8 Public Advocate in writing that the office will pursue the case, the Public Advocate shall  
9 suspend its own investigation.

10 Before making a determination whether alleged conduct may constitute a violation of  
11 conflict of interest or governmental ethics laws, the Public Advocate shall consult with the City  
12 Attorney. Before making a determination whether alleged conduct may constitute a violation of  
13 criminal law, the Public Advocate shall consult with the District Attorney.

14 (c) Notwithstanding any provision of this Charter, including but not limited to  
15 Section C3.699-11, or any ordinance, resolution, or regulation of the City, the Public Advocate  
16 shall administer a whistleblower and citizen complaint hotline telephone number and website  
17 and publicize the hotline and website through press releases, public advertising, and  
18 communications to City employees. The Public Advocate shall receive and track telephone calls,  
19 emails and other electronic communications, and other communications, related to complaints  
20 about wasteful and inefficient City government practices, misuse of government funds and  
21 improper activities by City government officials, employees, and contractors, and shall route  
22 these complaints to the appropriate agency subject to subsection (a) of this Section 8C.105. The  
23 Board of Supervisors shall enact an ordinance protecting the confidentiality of whistleblowers,  
24 and protecting City officers and employees from retaliation for filing a complaint with, or  
25 providing information to, the Public Advocate, Controller, Ethics Commission, District Attorney.

1 City Attorney, or a City department or commission about improper government activity by City  
2 officers and employees. The City may incorporate all or part of the whistleblower functions set  
3 forth in this Charter or by ordinances into a unified City call center, switchboard, or information  
4 number at a later time, provided the responsibility for the whistleblower function remains with  
5 the Public Advocate and its responsibilities and function continue consistent with this Section.

6  
7 **SEC. 8C. 106. PUBLIC ADVOCATE—CUSTOMER SERVICE PLANS.**

8 The Public Advocate shall assess the progress of City departments' compliance with  
9 Charter Section 16.120 and any implementing ordinances requiring City departments to prepare  
10 effective customer service plans. The Public Advocate shall make recommendations to  
11 departments to improve the effectiveness of such plans, or to the Mayor and the Board of  
12 Supervisors regarding improvements in such plans generally. The Public Advocate shall report  
13 to the Board of Supervisors and Mayor the failure of any department to comply substantially  
14 with the Public Advocate's recommendations regarding customer service plans.

15  
16 **SEC. 8C.107. PUBLIC ADVOCATE—OFFICE OF CITIZEN COMPLAINTS.**

17 (a) The Office of Citizen Complaints (OCC) shall be a department under the Public  
18 Advocate.

19 (b) The Public Advocate shall appoint a Director of the OCC, subject to confirmation by  
20 the Board of Supervisors. If the Board rejects the appointment, the Public Advocate shall make  
21 additional nominations. If the Board fails to act on an appointment within 30 days, the  
22 appointment shall be deemed approved. If the position of Director is vacant, the Public  
23 Advocate shall exercise the powers and duties of the Director until a new Director is appointed  
24 and confirmed. The transfer of the appointing power for the Director of the Office of Citizen  
25 Complaints from the Mayor to the Public Advocate shall not alter or affect the status of the

1 person serving as Director on the day the Charter amendment adding this Section 8C.107 takes  
2 effect.

3 (c) The Director shall serve at the pleasure of the Public Advocate, and the position of  
4 Director shall be exempt from the civil service requirements of this Charter. The Director shall  
5 never have been a uniformed member or employee of the Police Department. The Director shall  
6 be the appointing officer under the civil service provisions of this Charter for the appointment,  
7 removal, or discipline of employees of the OCC.

8 (d) Subject to the civil service provisions of this Charter, the OCC shall include  
9 investigators and hearing officers, in admission to administrative and clerical employees. The  
10 staff of the OCC shall consist of no fewer than one line investigator for every 150 sworn  
11 members. Whenever the ratio of investigators to police officers specified by this subsection (d) is  
12 not met for more than 30 consecutive days, the Director shall have the power to hire, and the  
13 Controller must pay, temporary investigators to meet that staffing requirement. No full-time or  
14 part-time employee of the OCC shall have previously served as a uniformed member of the  
15 Police Department. With the approval of the Public Advocate, the Director may appoint part-  
16 time hearing officers who shall be exempt from the civil service requirements of this Charter.  
17 Compensation of the hearing officers shall be at rates recommended by the Public Advocate and  
18 established by the Board of Supervisors or by contract approved by the Board of Supervisors.

19 (e) Complaints of police misconduct or allegations that a uniformed member of the  
20 Police Department has not properly performed a duty shall be promptly, fairly, and impartially  
21 investigated by the OCC, except those complaints which (1) on their face clearly indicate that the  
22 acts complained of were proper, or (2) were lodged by a uniformed member of the Police  
23 Department.

24 (f) The OCC shall use its best efforts to conclude investigations of such complaints and,  
25 if sustained, transmit the sustained complaint to the Police Department within nine months of

1 receipt thereof by the OCC. If the OCC sustains a complaint regarding conduct that may  
2 constitute a violation of criminal law, it shall promptly notify the District Attorney of that fact. If  
3 the OCC does not conclude its investigation within such nine-month period, the Director, within  
4 such nine-month period, shall inform the Chief of Police of the reasons therefor and transmit  
5 information and evidence from the investigation as shall facilitate the Chief's timely  
6 consideration of the matter.

7 (g) The OCC shall recommend disciplinary action to the Chief of Police on those  
8 complaints it sustains. The Director, after meeting and conferring with the Chief of Police or his  
9 or her designee, may verify and file charges with the Police Commission against members of the  
10 Police Department arising out of sustained complaints; provided, that the Director may not  
11 verify and file such charges for a period of 60 days following the transmittal of the sustained  
12 complaint to the Police Department unless the Director issues a written determination that the  
13 limitations period within which the member or members may be disciplined under Government  
14 Code Section 3304, as amended from time to time or any successor provisions thereto, may  
15 expire within such 60-day period and either (1) the Chief of Police fails or refuses to file charges  
16 with the Police Commission arising out of the sustained complaint, (2) the Chief of Police or his  
17 or her designee fails or refuses to meet and confer with the Director on the matter, or (3) other  
18 exigent circumstances necessitate that the Director verify and file charges to preserve the ability  
19 of the Police Commission to impose punishment pursuant to Section A8.343.

20 (h) The Director of the OCC shall schedule hearings before hearing officers when such  
21 is requested by the complainant or a member of the Police Department and, in accordance with  
22 rules of the Police Commission, such a hearing will facilitate the fact-finding process.

23 (i) The Board of Supervisors may provide by ordinance that the OCC shall in the same  
24 manner investigate and make recommendations to the Chief of Police regarding complaints of  
25 misconduct by patrol special police officers and their uniformed employees.



1           (j) Nothing herein shall prohibit the Chief of Police or a commanding officer from  
2 investigating the conduct of a member of the department under his or her command, or taking  
3 disciplinary or corrective action, otherwise permitted by this Charter, when such is warranted;  
4 and nothing herein shall limit or otherwise restrict the disciplinary powers vested in the Chief of  
5 Police and the Police Commission by other provisions of this Charter.

6           (k) The OCC shall prepare monthly summaries of the complaints received and shall  
7 prepare recommendations to the Police Commission quarterly concerning policies or practices  
8 of the Police Department which could be changed or amended to avoid unnecessary tension with  
9 the public or a definable segment of the public while insuring effective police services. The OCC  
10 shall prepare a report for the President of the Board of Supervisors each quarter. The OCC  
11 shall provide copies of the report to the City Attorney and District Attorney. This report shall  
12 include, but not be limited to, the number and type of complaints filed, the outcome of the  
13 complaints, and a review of the disciplinary action taken, including a comparison of disciplinary  
14 action recommended by the OCC and discipline imposed by the Chief of Police and/or the Police  
15 Commission. The President of the Board of Supervisors shall refer this report to the appropriate  
16 committee of the Board of Supervisors charged with public safety responsibilities. Said  
17 committee may issue recommendations as needed.

18           (l) In carrying out its objectives, the OCC shall receive prompt and full cooperation and  
19 assistance from all organs of City government, including departments, officers, and employees,  
20 which shall promptly produce all records requested by the OCC, including, but not limited to,  
21 police officer personnel records and disciplinary records, except for records protected by a  
22 privilege under federal, state, or local law, or the disclosure of which to the OCC is prohibited  
23 by law, including, but not limited to, criminal investigation and prosecution files. The Director  
24 may request and the Chief of Police shall require the testimony or attendance of any member of  
25 the Police Department to carry out the responsibilities of the Office of Citizen Complaints.

2 **SEC. 8C.108. PUBLIC ADVOCATE—FUNDING.**

3 (a) Notwithstanding any other provision of this Charter, the Mayor and Board of  
4 Supervisors shall appropriate each year an amount equal to at least three one-hundredths of one  
5 percent (0.03%) of the City's overall budget, apportioned by fund and excluding bonded  
6 indebtedness, to fund the office of the Public Advocate.

7 (b) In addition to the amount required under subsection (a), the Mayor and Board of  
8 Supervisors shall appropriate each year to the office of the Public Advocate an amount equal to  
9 at least the amount appropriated to:

10 (1) the Office of Labor Standards Enforcement;

11 (2) the Controller for administration of the Whistleblower Program under

12           (a) Except in the case of an appointment or election to fill a vacancy, the term of office

7 Community College District shall be elected.

8 (6) At a special municipal election to be held on November 7, 2017, a Public  
9 Advocate shall be elected. Thereafter, at the general municipal election in 2020 and every  
10 fourth year thereafter, the Public Advocate shall be elected. Notwithstanding any other  
11 provision of this Charter including Section 6.100, the term of office for the person elected Public  
12 Advocate at the special municipal election on November 7, 2017, shall expire at noon on  
13 January 8, 2021.

14 (7) (6) The election and terms of office of members of the Board of Supervisors  
15 shall be governed by Section 13.110.

17 **SEC. 13.101.5. VACANCIES.**

18 (a) If the office of Assessor-Recorder, City Attorney, District Attorney, Public Defender,  
19 Sheriff, Treasurer, or Member of the Board of Supervisors, Board of Education, or Governing  
20 Board of the Community College District becomes vacant because of death, resignation, recall,  
21 permanent disability, or the inability of the respective officer to otherwise carry out the  
22 responsibilities of the office, the Mayor shall appoint an individual qualified to fill the vacancy  
23 under this Charter and state laws. If the office of Public Advocate becomes vacant because of  
24 death, resignation, recall, permanent disability, or the inability of the incumbent to otherwise

3 (b) If the Office of Mayor becomes vacant because of death, resignation, recall,

5 of the Board of Supervisors shall become Acting Mayor and shall serve until a successor is  
6 appointed by the Board of Supervisors by motion.

7 (c) Any person filling a vacancy pursuant to subsection (a) or (b) of this Section shall  
8 serve until a successor is selected at the next election occurring not less than 120 days after the  
9 vacancy, at which time an election shall be held to fill the unexpired term, provided that (1) if an  
10 election for the vacated office is scheduled to occur less than one year after the vacancy, the  
11 appointee shall serve until a successor is selected at that election or (2) if an election for any seat  
12 on the same board as the vacated seat is scheduled to occur less than one year but at least 120  
13 days after the vacancy, the appointee shall serve until a successor is selected at that election to  
14 fill the unexpired term.

15 ~~(d) If no candidate receives a majority of the votes cast at an election to fill a vacated~~

24 transferred to the next-ranked candidate, the continuing candidate with the fewest votes from the

[Charter Amendment - Public Advocate]

**Describing and setting forth a proposal to the voters, at an election to be held on November 8, 2016, to amend the Charter of the City and County of San Francisco to: 1) create the Office of the Public Advocate; 2) set the Public Advocate's powers and duties; 3) authorize the Public Advocate to review the administration of City programs, including programs for transmitting information to the public, and to receive, investigate, and attempt to resolve complaints regarding City services and programs; 4) place the Public Advocate in charge of the Office of Labor Standards Enforcement, the Office of Citizen Complaints, and the Controller's whistleblower program; 5) call a special election for November 7, 2017 to elect the first Public Advocate; 6) provide for the Public Advocate's election, removal, and salary; and 7) establish a set-aside of .03% of the City's budget, as well as the amounts previously budgeted to OLSE, OCC, and the whistleblower program, to fund the Office of the Public Advocate, and setting an operative date.**

Existing Law

The City currently does not have a particular official or central office responsible for overseeing how City departments interact with the public. The City has an Office of Labor Standards Enforcement under the City Administrator, a whistleblower program under the Controller, and an Office of Citizen Complaints under the Police Commission.

Amendments to Current Law

The proposal is a charter amendment that would create the Office of the Public Advocate.

The Public Advocate would review the administration of City programs, including the distribution of programs and services throughout the City, the effectiveness of the public information and service complaint programs of City agencies, and the responsiveness of City agencies to individual and group requests for data or information regarding the agencies' structure, activities, and operations. The Public Advocate would also review the management and employment practices of City officers and departments, including City policies and MOU provisions, that promote or impede the effective and efficient operation of City government, and would review the City's contracting procedures and practices. And the Public Advocate would investigate and attempt to resolve complaints from members of the public concerning City services and programs.

The proposal would place the Public Advocate in charge of the City's Office of Labor Standards Enforcement (OLSE), whistleblower program, and Office of Citizen Complaints (OCC). The functions and duties of those entities would not change. The Public Advocate would appoint and remove the Director of OCC.

The Public Advocate could introduce legislation at the Board of Supervisors to address any matter within the Public Advocate's jurisdiction.

The Public Advocate could not interfere with specific contract or personnel decisions or other administrative actions, or with criminal investigations or prosecutions. And during his or her tenure, the Public Advocate could not contribute to, or publicly endorse or oppose, a candidate for City elective office, or be an officer, director, or employee of an organization that makes political endorsements regarding candidates for City elective office.

The first Public Advocate would be elected at a special election to be held on November 7, 2017, and would serve a shortened term. Beginning in November 2020, the Public Advocate would be elected for a four-year term, using ranked-choice voting.

If the office of Public Advocate became vacant, the Chief Deputy Public Advocate would serve as Public Advocate until a successor was elected at the next election occurring not less than 120 days after the vacancy. The Mayor could file written charges of official misconduct against the Public Advocate and those charges would be heard and acted on by the Ethics Commission and the Board of Supervisors in the same manner as other charges of official misconduct, but the Mayor would have no power to suspend the Public Advocate prior to the determination of those charges by the Board of Supervisors.

The Civil Service Commission would set the salary of the Public Advocate at the average of the salaries for the offices of Mayor, City Attorney, District Attorney, Public Defender, Assessor-Recorder, Treasurer, Sheriff, and Member of the Board of Supervisors.

The proposal would require the City to appropriate each year an amount equal to at least three one-hundredths of one percent (0.03%) of the City's overall budget to fund the office of the Public Advocate, and to appropriate an amount equal to the budget for OLSE, the whistleblower program, and OCC for fiscal year 2015-2016, 2016-2017, or 2017-2018, whichever amount is greatest by fiscal year for each entity. The set-aside for the Controller's audit fund would be reduced from 0.2% of the City's overall budget to 0.1914%.

The proposal would become operative at noon on January 8, 2018.

Dear Ms. Calvillo,

Should the proposed charter amendment be approved by the voters, in my opinion, it would result in a significant increase in the cost of government.

Beginning in fiscal year 2017-18, there would be a new cost of approximately \$2.4 million annually under a budget set-aside required to fund a new Office of the Public Advocate, and this cost would increase or decrease at the same rate as the City budget going forward.

The proposed amendment would also move three existing functions from other City departments and place them under the Public Advocate. These are; the Office of Citizen Complaints which investigates citizen complaints regarding the Police, the Office of Labor Standards Enforcement which enforces and investigates complaints regarding violations of the City's wage and other labor laws, and the Controller's Whistleblower Program which investigates complaints regarding any misuse of public resources. Taken together, these functions are now budgeted at approximately \$12.8 million. The overall budget for the Office of the Public Advocate including the new set-aside and the budget requirements based on existing functions would be approximately \$15.2 million annually.

The proposed amendment requires a citywide special election in November 2017 at which the Public Advocate would be elected for an initial two year term. Thereafter, the Office of the Public Advocate would be included in the citywide four year election cycle beginning in November 2020 and would serve four year terms. The additional citywide special election would have a one-time cost of approximately \$4 million in the fiscal year 2017-18 budget.

The new required budget set-aside for the Public Advocate is set at three one-hundredths of one percent (0.03%) of the City budget, approximately \$2.4 million as of fiscal year 2016-2017. The amendment also reduces the existing budget set-aside of the Controller's City Services Auditor approved by voters in 2003 from two tenths of one percent (0.2%) to (0.1914%), a change equal to approximately \$688,000 as of the current budget.




The proposed new Office of the Public Advocate would have a variety of powers to review, investigate and make recommendations regarding the City's public information programs, complaint resolution processes, and its management, contracting and employment practices. The authority and responsibility to perform these functions currently exists in various City departments. The proposed amendment does not substantially change these existing responsibilities. The Public Advocate would have the authority to introduce legislation.

The salary for the new Public Advocate would be set at the average of the other citywide elected officials—approximately \$216,000 annually based on current rates.

This proposed amendment is not in compliance with a non-binding, voter-adopted city policy regarding set-asides. The policy seeks to limit set-asides which reduce General Fund dollars that could otherwise be allocated by the Mayor and the Board of Supervisors in the annual budget process.

Note that the proposed amendment would change the budget, powers and duties of the Controller's Office, which has prepared this statement.

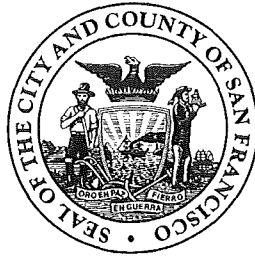


