9 WHEREAS, The Municipal Transportation Agency ("MTA"), as authorized by Charter
10 Section 8A.104 (c), assumed responsibility for administration of its Workers' Compensation
11 claims beginning July 1, 2000; and

12 WHEREAS, The current contract for Workers' Compensation Third Party Claims
13 Administration Services with Intercare Insurance Services expires on April 25, 2004; and

14 WHEREAS, The MTA Board authorized staff to issue a Request for Proposals for
15 Workers' Compensation Claims Administration Services on December 2, 2003; and

16 WHEREAS, Under San Francisco Charter section 9.118(b), Board of Supervisors
17 authorization is required for the Director of Transportation to enter into any contract where the
18 total anticipated value exceeds \$10 million; ~~now, therefore, be it~~ and

19 WHEREAS, Sedgwick Claims Management Services was the top rated proposer at the
20 conclusion of a competitive selection process; ~~now, therefore, be it~~ and

21 WHEREAS, Under San Francisco Charter section 9.118(b), Board of Supervisors
22 authorization is required for the Director of Transportation to enter into any contract where the




