15 clinicians, administrators, policy makers, and other community leaders from around the world
16 to San Francisco to seek treatment strategies; and,

17 WHEREAS, The conference will address six areas of importance in current treatment
18 practices within the therapeutic community: Policy and the Social Context, Trends in
19 Substance Abuse Treatment, Co-Existing Medical Conditions, Unique Problems of Special
20 Populations, Co-Existing Mental Illness, and Criminal Justice; now, therefore, be it

21 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
22 commends the World Federation of Therapeutic Communities upon its 20th annual
23 conference; and, be it

24 FURTHER RESOLVED, That the Board declares September 2, 2000 "World
25 Federation of Therapeutic Communities Day" in the City and County of San Francisco.




