3 **Resolution requesting the Board of Supervisors to approve the expenditure of funds**
4 **for emergency slope and drainage repair at the SFPUC Harry Tracy Water Treatment**
5 **Plant, in the amount of \$2.5 million.**

7 WHEREAS, On February 22, 2005, SFPUC staff identified slope and drainage pipe
8 failure threatening the San Antonio Pipeline No. 2 (SA-2) raw water supply pipeline; and,

9 WHEREAS, In the opinion of SFPUC engineers, this slope and drainage damage has a
10 substantial likelihood of imminent failure of the SA-2 pipeline to the Harry Tracy Water
11 Treatment Plant if it is not repaired; and,

12 WHEREAS, Rupture of the supply pipeline would result in serious impact to the plant's
13 water treatment capacity; and

14 WHEREAS, The General Manager of the Public Utilities Commission notified the
15 Controller and Clerk of the Board of Supervisors of her decision to declare an emergency to
16 repair slope and drainage damage at the Harry Tracy Water Treatment Plant (HTWTP), by a
17 letter dated April 14, 2005, to the Controller and Clerk of the Board of Supervisors on file with
18 the Clerk of the Board of Supervisors in File No. 050850, stating the nature of the emergency
19 work and its estimated cost which is hereby declared to be a part of this resolution as if set
20 forth fully herein; and

21 WHEREAS, The San Andreas Pipeline No. 2 at the HTWTP was threatened by a slope
22 failure and was in imminent danger of failure by collapse; and

23 WHEREAS, the Declaration of Emergency was approved by the President of the Public
24 Utilities Commission and ratified by the Commission per Resolution No. 05-0064 on April 26,
25 2005; and

1 WHEREAS, The Human Rights Commission granted an emergency waiver of the
2 subcontracting goals and sole source waiver pursuant to Chapter 12D.A of the San Francisco
3 Administrative Code; and

4 WHEREAS, Construction work will begin after award of the repair contract; and

5 WHEREAS, The estimated cost is \$2.5 million, and the duration will be 90 consecutive
6 calendar days; and

7 WHEREAS, Funds for this contract are available from SFPUC Project Nos. CUW161 –
8 Rehabilitation of Treatment Facilities and CUW240 – Pipeline Rehabilitation; and

9 WHEREAS, The approval of this emergency construction contract is in accordance
10 with Chapter 6, Article IV, Section 6.60(D) of the San Francisco Administrative Code; now,
11 therefore, be it

12 RESOLVED, That an expenditure of funds for emergency construction contract No.
13 WD-2494E, Harry Tracy Water Treatment Plant – Slope and Drainage Repairs, for slope
14 and drainage damage repair at the Harry Tracy Water Treatment Plant for \$2.5 is approved in
15 accordance with Chapter 6, Article IV, Section 6.60(D) of the San Francisco Administrative
16 Code.




