6 MOVED, That pursuant to Section 540 of the Municipal Elections Code, the Board of
7 Supervisors does hereby authorize a rebuttal to opponent's ballot argument against
8 Proposition G, a Charter amendment amending Section 13.110 to provide that the Elections
9 Commission, rather than the Director of Elections, shall appoint three members to the
10 Elections Task Force; to require the use of adjusted census figures in redistricting
11 Supervisorial districts; and to set deadlines for creation of the Elections Task Force and for
12 completion of redistricting; and, be it

13 FURTHER MOVED, That the full text of said rebuttal ballot argument hereby authorized be
14 shown in the copy attached to this motion and is hereby declared to be a part hereof; and, be
15 it

16 FURTHER MOVED, That the Director of Elections be and is hereby authorized and directed
17 to include said argument in the pamphlet accompanying the sample ballots to be mailed to the
18 voters of the City and County of San Francisco for the election to be held on Tuesday,
19 November 6, 2001.
