3 **Resolution determining that the person-to-person, premise-to-premise transfer of**  
4 **a Type-20 off-sale beer and wine liquor license to Save Mart Supermarkets, LLC,**  
5 **doing business as Save Mart, located at 3801 - 3<sup>rd</sup> Street (District 10), will serve**  
6 **the public convenience or necessity of the City and County of San Francisco; and**  
7 **requesting that the California Department of Alcoholic Beverage Control impose**  
8 **conditions on the issuance of the license.**

10 WHEREAS, Save Mark Supermarkets, LLC is seeking the person-to-person,  
11 premise-to-premise transfer of a Type-20 off-sale beer and wine liquor license to do  
12 business as Save Mart, located at 3801 - 3<sup>rd</sup> Street (District 10); and

13 WHEREAS, The Planning Department has verified that the area is properly  
14 zoned and recommends approval; and

15 WHEREAS, The Police Department has filed zero protests and zero letters of  
16 support with the Department of Alcoholic Beverage Control under California Business  
17 and Professions Code, Section 24013, and recommends that the Department of  
18 Alcoholic Beverage Control issue the liquor license with conditions; and

19 WHEREAS, The condition recommended by the Police Department is the  
20 following: 1) Petitioner(s) shall actively monitor the area under their control in an effort  
21 to prevent the loitering of persons on any property adjacent to the licensed premises as  
22 depicted on the ABC-251; now, therefore, be it

23 RESOLVED, That in accordance with California Business and Professions Code,  
24 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
25 hereby determines that the person-to-person, premise-to-premise transfer of a Type-20

1 off-sale beer and wine liquor license to Save Mark Supermarkets, LLC, doing business  
2 as Save Mart, located at 3801 - 3<sup>rd</sup> Street (District 10), will serve the public convenience  
3 or necessity of the City and County of San Francisco; and, be it

4 FURTHER RESOLVED, That the Board of Supervisors of the City and County of  
5 San Francisco hereby endorses and adopts the recommendations of the Police  
6 Department listed above and recommends that the Department of Alcoholic Beverage  
7 Control issue the license with those conditions.
