3	Resolution enacting and rescinding parking regulations at various locations
4	RESOLVED, That, in accordance with the provisions of the California Vehicle
5	Code and the San Francisco Traffic Code, the following regulations governing the
6	parking of vehicles are hereby enacted or rescinded as designated below:
7	RESIDENTIAL PERMIT PARKING AREA "X" (2-HOUR TIME LIMIT, 8 AM - 6 PM MONDAY THROUGH FRIDAY) - ESTABLISH
8 9	Missouri Street, both sides, between 20th and 22nd Streets (500 and 600 blocks); and
10	Sierra Street, north side, between Missouri and Texas Streets.
11	TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH
12	Plymouth Avenue, east side, from Monterey Boulevard to 60 feet northerly;
13 14	Cesar Chavez Street, north side, from 35 feet to 85 feet east of Connecticu Street (extends existing 35-foot zone by an additional 50 feet); and
15	Cesar Chavez Street, south side, from Connecticut Street to 85 feet easterly.
16	PERPENDICULAR (90-DEGREE ANGLE) PARKING - ESTABLISH
17	Ellis Street, south side, from Laguna Street to 350 feet westerly (legislates existing conditions);
18	Waller Street, north side, from Divisadero Street to Broderick Street (legislates
19	existing conditions); and
20	Market Street, north side, between the east and west curb lines of Steuar Street.
21	TOW-AWAY, NO PARKING ANYTIME - ESTABLISH
22	Edgar Place, east side, from 80 feet south of Niagara Avenue to the southerr terminus (unit block).
2324	NO PARKING ANYTIME - RESCIND NO PARKING, 7 AM TO 6 PM, EXCEPT SUNDAY - ESTABLISH
25	Nido Avenue, west side, between Turk and Vega Streets; and

1	vega Street, north side, between Anza vista and Nido Avenues.
2	TOW-AWAY NO PARKING, 9 PM TO 6 AM, EXCEPT SATURDAY AND SUNDAY -
3	RESCIND 10-MINUTE GREEN ZONE, 9 AM TO 6 PM, EVERYDAY - RESCIND DARKING METER AREA NO. 1 (20 MINUTE METERS 7 AM TO 6 PM, EVERYDAY)
4	PARKING METER AREA NO. 1 (30-MINUTE METERS, 7 AM TO 6 PM, EVERYDAY) - EXTEND
5	Market Street, north side, between the east and west curb lines of Steuart Street.
6	
7	TOW-AWAY, NO STOPPING, 3 PM TO 6 PM, EVERYDAY - RESCIND TOW-AWAY, NO STOPPING, 3 PM TO 7 PM, EVERYDAY - ESTABLISH
8	3rd Street, both sides, from Mission to Market Streets; and
9	3rd Street, west side, from Howard to Mission Streets.

11	Categorically exempt from Environmental Review Class
12	1(c)(9) changes in the traffic and parking regulations where such changes do not establish a higher speed
13	limit or result in more than a negligible increase in the use of the street.
