

1 [Accept-Expend Grant Awarded to the San Francisco Department of the Environment by
2 Golden Gate University School of Law, Environmental Law and Justice Clinic]

3 **Resolution authorizing the San Francisco Department of the Environment to accept**
4 **and expend a grant in the amount of \$23,000.00 from the Environmental Law and**
5 **Justice Clinic of the Golden Gate University School of Law for administrative and**
6 **outreach services relating to a Clean Air Act educational workshop and an**
7 **Environmental Justice conference to bring together governmental agencies,**
8 **community groups, activists and academic institutions.**

9 WHEREAS, the Environmental Law and Justice Clinic (ELJC) of the Golden Gate
10 University School of Law received a federal grant award in the amount of \$70,000 from the
11 U.S. Environmental Protection Agency (EPA Grant ID No. XA-83142901-0) to conduct two
12 events: (1) an educational workshop on the federal Clean Air Act (CAA) for environmental
13 justice activists and community groups; and (2) an Environmental Justice (EJ) conference that
14 brings together federal, state and regional regulatory agencies, community groups, activists
15 and academic institutions to promote awareness of EJ concerns in the context of the federal
16 Clean Air Act permitting programs; and,

17 WHEREAS, the ELJC requested assistance from the Environmental Justice program of
18 the San Francisco Department of the Environment (SFE) to help plan, organize and conduct
19 outreach for the CAA educational workshop and EJ conference; and,

20 WHEREAS, the ELJC will provide a grant award in the amount of \$23,000.00 to the
21 Environmental Justice program of SFE as compensation for its staff time and effort, for
22 conducting administrative and outreach services related to the CAA educational workshop
23 and EJ conference; and,

24 WHEREAS, the CAA workshop and EJ conference are consistent and supportive of the
25 SFE Environmental Justice program's strategic plan goals of providing educational services to



2 improve an understanding of environmental programs and policies; and,


3 WHEREAS, indirect costs of \$2091.00 are included in the budget; now therefore, be it




