9 WHEREAS, The City and County is a designated local area for the Workforce  
10 Investment Act of 1998 ("WIA"), 29 U.S.C. Section 2801, et seq.; and,

11 WHEREAS, Each local area receives an annual allocation of Workforce Investment Act  
12 funding in the form of a Rapid Response grant from the state in which the local area is  
13 located, for dislocation assistance services in that area; and,

14 WHEREAS, The Department of Economic and Workforce Development is the fiscal  
15 and programmatic administrator for the Workforce Investment Act funds; and,

16 WHEREAS, The WIA requires the Chief Local Elected Official to appoint a local  
17 workforce investment board which oversees the expenditure of WIA funds in the local area;  
18 and

19 WHEREAS, The grant terms prohibit including indirect costs in the grant budget; now,  
20 therefore, be it

21 ORDAINED, That the Department of Economic and Workforce Development is  
22 authorized to accept and expend a grant in the amount of \$307,375.00 in FY 2007-2008 from  
23 the California Employment Development Department for workforce development; and be it

24 FURTHER ORDAINED, That the Board of Supervisors hereby waives inclusion of  
25 indirect costs in the grant budget; and be it




