5	Graduates, under the All Children And Youth Are Ready To Learn And Succeed In
6	School Result Area for the following five school programs: Bessie Carmichael Beacon,
7	Everett Middle School Beacon, Flynn Elementary School Beacon, Sanchez Elementary
8	School Beacon, and Mission HS/O'Connell HS/June Jordan SE Summer Program, for a
9	term of five years from July 1, 2024, through June 30, 2029, and for a total not to
10	exceed amount of \$10,717,300; and to authorize DCYF to enter into amendments or
11	modifications to the Agreement that do not materially increase the obligations or
12	liabilities to the City and are necessary to effectuate the purposes of the Agreement or
13	this Resolution.

15	WHEREAS, On August 16, 2023, the Department of Children, Youth and Their
16	Families (DCYF) issued a Request for Proposals ("RFP") for its 2024–2029 funding cycle; and
17	WHEREAS, Mission Graduates submitted proposals for five school programs under
18	RFP Result Area: All Children And Youth Are Ready To Learn And Succeed In School and
19	was the highest ranked proposer; and
20	WHEREAS, The five school programs are: Bessie Carmichael Beacon; Everett Middle
21	School Beacon; Flynn Elementary School Beacon; Sanchez Elementary School Beacon; and
22	Mission HS/O'Connell HS/June Jordan SE Summer Program; and
23	WHEREAS, Under the Bessie Carmichael Beacon Program, Mission Graduates will
24	provide academic supports and enrichment activities at Bessie Carmichael K-8 School; and
25	

1	WHEREAS, Under the Everett Middle School Beacon Program, Mission Graduates will
2	provide academic supports and enrichment activities at Everett Middle School; and
3	WHEREAS, Under the Flynn Elementary School Beacon Program, Mission Graduates
4	will provide academic supports and enrichment activities at Leonard Flynn Elementary School
5	and
6	WHEREAS, Under the Sanchez Elementary School Beacon Program, Mission
7	Graduates will provide academic supports and enrichment activities at Sanchez Elementary
8	School; and
9	WHEREAS, Under the Mission HS/O'Connell HS/June Jordan SE Summer Program,
10	Mission Graduates will provide a summer learning program for five days a week for four hours
11	a day over eight weeks serving 100 San Francisco youth; and
12	WHEREAS, DCYF awarded the Agreement to Mission Graduates for all five school
13	programs; and
14	WHEREAS, Charter, Section 9.118(b) requires Board of Supervisors' approval by
15	Resolution of any contract which, when entered into, extends over 10 years, and of any
16	contract which, when entered into, costs the City \$10,000,000 or more; and
17	WHEREAS, The proposed Agreement contained in File No, is substantially in
18	final form, with all material terms and conditions included, and only remains to be executed by
19	the parties upon approval of this Resolution; now, therefore, be it
20	RESOLVED, That the Board of Supervisors hereby approves the Agreement in
21	substantially the form contained in File No; and, be it
22	FURTHER RESOLVED, That the Board of Supervisors authorizes DCYF to make any
23	modifications to the Agreement, prior to its final execution by all parties, that DCYF
24	determines, in consultation with the City Attorney, are consistent with this Resolution, in the
25	best interest of the City, do not materially increase the obligations or liabilities of the City, are

1	necessary or advisable to effectuate the purposes of the Agreement, and are in compliance
2	with all applicable laws, including City's Charter; and, be it
3	FURTHER RESOLVED, That within 30 days of the Agreement being fully executed by
4	all parties, DCYF shall submit to the Clerk of the Board of Supervisors a completely executed
5	copy for inclusion in File No; this requirement and obligation resides with the
6	Department, and is for purposes of having a complete file only, and in no manner affects the
7	validity of approved Agreement.
