5	the County Clerk may impose a \$40 filing fee for all Declarations of Domestic
6	Partnership and all Amendments to a Declaration of Domestic Partnership, and to
7	provide for annual adjustment of those fees and of the fees for domestic partnership
, 8	ceremonies to reflect changes in the Consumer Price Index.

11	Be it ordained by the People of the City and County of San Francisco:
12 13	Section 1. Findings
13	The Planning Department has determined that the actions contemplated in this
15	Ordinance are in compliance with the California Environmental Quality Act (California Public
16	Resources Code sections 21000 et seq.). Said determination is on file with the Clerk of the
17	Board of Supervisors in File No and is incorporated herein by reference.
18	Section 2.
19	The San Francisco Administrative Code is hereby amended by amending section
20	8.33.1 as follows:

1 (b) Beginning with fiscal year 2003-2004, fees set in this Section may be 2 adjusted each year, without further action by the Board of Supervisors, to reflect changes in 3 the relevant Consumer Price Index, as determined by the Controller.

4 No later than April 15th of each year, the County Clerk shall submit its current 5 fee schedule to the Controller, who shall apply the price index adjustment to produce a new 6 fee schedule for the following year.

7 No later than May 15th of each year, the Controller shall file a report with the 8 Board of Supervisors reporting the new fee schedule and certifying that: (a) the fees produce 9 sufficient revenue to support the costs of providing the services for which each fee is

10 assessed, and (b) the fees do not produce revenue which is significantly more than the costs

11 of providing the services for which each fee is assessed. (Added by Ord. 323-98, App.

14 The San Francisco Administrative Code is hereby amended by amending Sections

15 62.8 and 62.9 to read as follows:

16 SEC. 62.8. FILING FEES.

17 For each filing of a Declaration of Domestic Partnership and each Amendment

18 to a Declaration of Domestic Partnership the County Clerk shall charge a fee of \$10 \$40. This

19 fee may be adjusted pursuant to Section 8.33.1(b) of this Code to reflect changes in the relevant

20 <u>Consumer Price Index as determined by the Controller.</u> (Added by Ord. 2-91, App. 1/14/91;

21 amended by Ord. 155-02, File No. 021079, App. 7/12/2002)

22 SEC. 62.9. CIVIL CEREMONY.

23 (a) The County Clerk and any other person authorized by state law to 24 perform marriage ceremonies are authorized to perform a civil ceremony solemnizing the 25 formation of a Domestic Partnership established in accordance with this Chapter. Persons

1 who either (1) present a signed Declaration of Domestic Partnership for filing to the County 2 Clerk in accordance with Section 62.3(a)(1), or who (2) present a certificate issued by the 3 County Clerk in accordance with Section 62.3(a)(1) showing that a signed Declaration of 4 Domestic Partnership for these persons has been previously filed with the County Clerk, may 5 request that the County Clerk or any other person authorized by state law to perform marriage 6 ceremonies perform a ceremony solemnizing the formation of their Domestic Partnership. 7 Each request for a Domestic Partnership ceremony by the County Clerk shall be made in 8 writing on a form provided by the County Clerk, and shall be accompanied by payment of a 9 fee of \$60, for a ceremony to be performed during regular business hours, and \$100, for a 10 ceremony to be performed on a weekend or holiday. These fees may be adjusted pursuant to 11 Section 8.33.1(b) of this Code to reflect changes in the relevant Consumer Price Index as determined

12 *by the Controller.*

13 (b) Upon completion of the ceremony authorized by Subsection (a), the 14 County Clerk shall issue a souvenir certificate memorializing the performance of the 15 ceremony. If the ceremony is performed by a person other than the County Clerk, the 16 persons entering into Domestic Partnership shall obtain a Ceremony Request Form from the 17 County Clerk prior to the ceremony and shall return such Ceremony Request Form to the 18 County Clerk within six months following the ceremony. The Ceremony Request Form shall 19 be signed by the officiant. The County Clerk shall keep a record of all such ceremonies 20 performed, filed with the Declaration of Domestic Partnership to which they apply. The County 21 Clerk shall keep a record of Domestic Partnership ceremonies.

(c) The County Clerk is authorized to deputize persons to solemnize
Domestic Partnership ceremonies. Any person 18 years of age or older may apply to be
deputized for this purpose. Approval of applicants and the terms of any such authorization

3 (d) The ceremony authorized by this Section shall have no legal effect	ct upon
4 the status of a Domestic Partnership established pursuant to this Chapter. (Added by	Ord.
