9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. The San Francisco Traffic Code is hereby amended by amending Section
11 32.6.30, to read as follows:

12 **SEC. 32.6.30 PARKING CONTROL, ~~PORTION~~ PORTIONS OF GREEN STREET AND**
13 **BAKER STREETS.**

14 No person shall stop, park, or leave standing any vehicle, whether attended or
15 unattended, 8:00 a.m. to 6:00 p.m., Monday through Friday, except on Holidays, at the
16 following locations:

17 (a) ~~on the north side of~~ Green Street, north side, from 15 feet to 75 feet east of Baker
18 Street (60-foot zone);

19 (b) Baker Street, east side, from 11 feet to 64 feet north of Green Street (53-foot zone);
20 except official vehicles displaying a valid permit issued by the Russian Consulate Embassy
21 authorizing parking in said zone. The permit exceptions under this Section shall not apply
22 when parking prohibition regulations for street-cleaning purposes are in effect.


