WHEREAS, by Resolution No. 18-0153, adopted May 15, 2018, the Commission approved the revised minimum qualification requirements and authorized Staff to accept proposals; and

WHEREAS, on June 20, 2018, Staff received one proposal for the Lease; and

WHEREAS, a three-member panel evaluated the proposal and determined InMotion Entertainment Group, LLC to be the most responsive and responsible proposer for the Electronics Stores Lease in Terminal 3 Boarding Areas E and F; now, therefore, be it

RESOLVED, that this Commission hereby awards the Electronics Stores Lease in Terminal 3
Boarding Areas E and F to InMotion Entertainment Group, LLC on the terms set forth in the Staff memorandum on file with the Commission Secretary with a lease term of 10 years and a Minimum Annual Guarantee of \$500,000.00 for the first year of the lease term; and, be it further

RESOLVED, that this Commission hereby directs the Commission Secretary to forward the Electronics Stores Lease in Terminal 3 Boarding Areas E and F to the Board of Supervisors for approval pursuant to Section 9.118 of the Charter of the City and County of San Francisco.

DIRECTOR'S RECOMMENDATION: (1) AWARD THE ELECTRONICS STORES LEASE IN TERMINAL 3 BOARDING AREAS E AND F TO INMOTION ENTERTAINMENT GROUP, LLC FOR A TERM OF 10 YEARS AND A MINIMUM ANNUAL GUARANTEE OF \$500,000.00 FOR THE FIRST YEAR OF THE LEASE TERM; AND (2) DIRECT THE COMMISSION SECRETARY TO REQUEST APPROVAL OF THE LEASE FROM THE BOARD OF SUPERVISORS.

### **Executive Summary**

The competitive selection process for the Electronics Stores Lease in Terminal 3 Boarding Areas E and F has concluded. I recommend awarding the Lease to InMotion Entertainment Group, LLC ("InMotion").

#### Background

On March 6, 2018, the Airport Commission ("Commission") adopted Resolution No. 18-0056 authorizing Staff to commence the Request for Proposals ("RFP") process for the Electronics Stores Lease in Terminal 3 Boarding Areas E and F ("Lease"). Staff presented the Lease to interested parties and gathered their feedback at an informational conference on April 4, 2018.

By Resolution No. 18-0153, adopted May 15, 2018, the Commission approved the revised minimum qualification requirements, and authorized Staff to accept proposals for the Lease. In response to the RFP, the Airport received one proposal by the June 20, 2018 submittal deadline from InMotion. Staff determined that the proposal met the RFP's minimum qualifications.

Staff convened a three-member panel to evaluate the proposal. The panel consisted of the following: an SFO Aviation Security Supervisor, a manager in SFO's Capital Finance Department, and a Senior Property Manager at Mineta San Jose International Airport. The evaluation panel determined that the proposer was responsive and responsible.

The Minimum Annual Guarantee ("MAG") proposed for the first year of the Lease is \$500,000.00, and rent will be the greater of the MAG or percentage rent. The term of the Lease is 10 years. InMotion is based in Florida and currently has four leases at the Airport, in addition to numerous locations at airports nationwide. InMotion has formed a joint venture partnership with APW Holdings, LLC, an Airport Concession Disadvantaged Business Enterprise ("ACDBE") certified company for this Lease. APW Holdings, LLC will have 15% ownership.

#### Recommendation

I recommend that the Commission: (1) award the Electronics Stores Lease in Terminal 3 Boarding Areas E and F to InMotion Entertainment Group, LLC for a term of 10 years and a Minimum Annual Guarantee of \$500,000.00 for the first year of the lease term; and (2) direct the Commission Secretary to request approval of the lease from the Board of Supervisors.
