7 **Department, and the Human Services Agency, contingent on approval, to accept, and**
8 **expend grant awards from agencies of the federal government in various amounts and**
9 **for a variety of purposes and projects; and calling from the Budget and Finance**
10 **Committee Board File Nos. 241131, 241174, 241217, 241216, 241176, and 241199 to the**
11 **Committee of the Whole for consideration on January 14, 2025.**

13 WHEREAS, The Port of San Francisco, Department of Public Works, Department of
14 Environment, Department of Public Health, Recreation and Park Department, and the Human
15 Services Agency have been awarded grant funding from federal agencies; and

16 WHEREAS, These grants will fund a variety of projects including the San Francisco
17 Waterfront Emissions-Free Ferry System, Bayview Connections: Phase 1 Harney Way BRT
18 and Cycletrack, Twin Peaks Promenade, Visitacion Avenue Pedestrian and Bicycle Safety
19 Improvements, Refugee Support Services Funding, and will fund the participation in programs
20 entitled "Strengthening STD Prevention and Control for Health Departments Program (STD
21 PCHD)", the "Comprehensive Opioid, Stimulant, and Substance Use Site-Based Program",
22 "CaAIM JI PATH Round 2 Funding – San Francisco", and "State Vocational Rehabilitation
23 Services Program"; and

24 WHEREAS, The cumulative amount of funding provided in these grant awards exceeds
25 \$130,000,000; and

1 WHEREAS, The resolutions approving the departments' acceptance and expenditure
2 of such grant funds are in Board File Nos: 241131, 241174, 241217, 241216, 241176,
3 241199, 250022, 250023, 250025, 250026, 250028, 250030, 250032, 250033, 250035; and

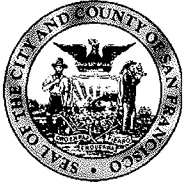
4 WHEREAS, The resolutions in Board File Nos. 241131, 241174, 241217, 241216,
5 241176, and 241199 have been referred to the Budget and Finance Committee, but the
6 remainder of the resolutions, Board File Nos. 250022, 250023, 250025, 250026, 250028,
7 250030, 250032, 250033, 250035 have not yet been referred to committee; and

8 WHEREAS, The Board of Supervisors wishes to consider approval of the Resolutions
9 expeditiously to ensure the City obtains this grant funding as soon as possible; now therefore,
10 be it

11 MOVED, That the Board of Supervisors convene to sit as a Committee of the Whole on
12 January 14, 2025, at 3:00 p.m., to hold a public hearing to consider approval of the 15
13 Resolutions identified above; and, be it

14 FURTHER MOVED, That, since the subject of the Resolutions is of an urgent nature,
15 the Board of Supervisors does not wish to delay the hearing on these matters and directs the
16 matters be heard in a Committee of the Whole the same day this Motion is considered for
17 approval; and, be it

18 FURTHER MOVED, That under Board Rule 3.38, the Board calls File Nos. 241131,
19 241174, 241217, 241216, 241176, and 241199 from the Budget and Finance Committee to
20 the Committee of the Whole on January 14, 2025.
