17 RESOLVED, That in accordance with Section 23958.4 of the California Business
18 and Professions Code, the Board of Supervisors of the City and County of San
19 Francisco hereby determines for the foregoing reasons that the transfer of a Type 20
20 off-sale beer and wine alcoholic beverage control licnese from 38th and Clement Golf
21 Course to 119 Sacramento Street (District 3) for David D. Davari for Focaccia Market
22 and Bakery, will serve the public convenience and necessity of the people of the City
23 and County of San Francisco.

24 Conditions: (1) The petitioner(s) shall be responsible for maintaining free of litter
25 the area adjacent to the premises over which they have control; (2) Sales and service of

1 alcoholic beverages shall be permitted only between the hours of 9:00 a.m. to 9:00 p.m.
2 each day of the week; (3) Petitioner shall regularly police the area under their control in
3 an effort to prevent the loitering of persons about the premises.


