3 **Resolution enacting and rescinding traffic regulations on various streets.**

5 RESOLVED, That, in accordance with the provisions of the California Vehicle  
6 Code and the San Francisco Traffic Code, the following regulations governing the  
7 movement of vehicles are hereby enacted or rescinded as designated below:

8 **NO TURNS - ESTABLISH**

9 Octavia Frontage Road, northbound, at Haight Street;

10 Octavia Frontage Road, northbound, at Fell Street; and

11 Octavia Frontage Road, southbound, at Oak Street.

12 **NO LEFT TURNS - ESTABLISH**

13 Octavia Boulevard, southbound, at Market Street;

14 Freeway off-ramp, (Octavia Boulevard) northbound, at Market Street;

15 Octavia Boulevard, northbound and southbound, at Haight Street;

16 Octavia Boulevard, northbound and southbound, at Page Street;

17 Octavia Boulevard, northbound and southbound, at Oak Street;

18 Octavia Frontage Road, southbound, at Haight Street;

19 Octavia Frontage Road, northbound and southbound, at Page Street;

20 Octavia Frontage Road, northbound and southbound, at Oak Street; and

21 Octavia Frontage Road, northbound and southbound, at Fell Street.

22 **MULTIPLE LEFT TURN LANES - ESTABLISH**

23 Octavia Boulevard, northbound, at Fell Street.

24 **MULTIPLE RIGHT TURN LANES - ESTABLISH**

25 Oak Street, eastbound, at Octavia Boulevard.

1 **RIGHT TURN ONLY - ESTABLISH**

2 Octavia Frontage Road, southbound, at Market Street;  
3 Waller Street, eastbound, at Market Street; and  
4 Octavia Frontage Road, southbound, at Fell Street.

5 **NO TURN ON RED - ESTABLISH**

6 Haight Street, eastbound and westbound, at Octavia Boulevard;  
7 Page Street, eastbound and westbound, at Octavia Boulevard;  
8 Market Street, Octavia Boulevard, Freeway Intersection, all approaches; and  
9 Oak Street, eastbound, at Octavia Boulevard.

10 **ONE-WAY STREET - ESTABLISH**

11 East Octavia Frontage Road, northbound, between Hayes and Market Streets;  
12 West Octavia Frontage Road, southbound, between Hayes and Market Streets;  
13 Lily Street, westbound, between Laguna Street and Octavia Boulevard (reverses  
14 direction);  
15 Rose Street, eastbound, between Gough Street and Octavia Boulevard (reverses  
direction);  
16 Elgin Park, southbound, between Duboce Avenue and McCoppin Street; and  
17 McCoppin Street, eastbound, between Elgin Park and Market Street.

18 **TOW-AWAY LANE MUST TURN LEFT - ESTABLISH**

19 Eastbound Oak Street at Laguna Street.

#### RIGHT TURN ONLY - ESTABLISH

Octavia Frontage Road, southbound, at Market Street;  
Waller Street, eastbound, at Market Street; and

#### NO TURN ON RED - ESTABLISH

Haight Street, eastbound and westbound, at Octavia Boulevard;  
Page Street, eastbound and westbound, at Octavia Boulevard;  
Market Street, Octavia Boulevard, Freeway Intersection, all approaches; and  
Oak Street, eastbound, at Octavia Boulevard.

#### ONE-WAY STREET - ESTABLISH

East Octavia Frontage Road, northbound, between Hayes and Market Streets;  
West Octavia Frontage Road, southbound, between Hayes and Market Streets;  
Lily Street, westbound, between Laguna Street and Octavia Boulevard (reverses direction);  
Rose Street, eastbound, between Gough Street and Octavia Boulevard (reverses direction);  
Elgin Park, southbound, between Duboce Avenue and McCoppin Street; and  
McCoppin Street, eastbound, between Elgin Park and Market Street.

#### TOW-AWAY LANE MUST TURN LEFT - ESTABLISH

Eastbound Oak Street at Laguna Street.


