

1 (PUBLIC TRANSPORTATION)

2 APPROVING AN AGREEMENT BETWEEN THE CITY AND COUNTY OF SAN
3 FRANCISCO AND THE BAY AREA RAPID TRANSIT DISTRICT AUTHORIZING
4 PAYMENT TO SAN FRANCISCO MUNICIPAL RAILWAY FOR TRANSFER TRIPS
5 PROVIDED IN FY99.

7 WHEREAS, The Municipal Railway's FY99 budget included a payment from BART
8 estimated at \$2,037,094; and

9 WHEREAS, That payment is based on a historical agreement whereby BART agrees to
10 annually reimburse MUNI to recognize that many BART patrons use MUNI to link up with their
11 BART trips, and that these patrons would not take BART at all were it not for the MUNI link;

14 WHEREAS, Historically BART has based its payment to MUNI on the prior year's
15 payment with adjustments for changes in BART sales tax revenues; and

16 WHEREAS, Approval of the annual payment has been done on an annual basis; and

17 WHEREAS, MUNI and BART staff have agreed that the amount due to MUNI for FY
18 1998-1999 is \$2,066,513; and

19 WHEREAS, On JUL 20 1999 the Public Transportation Commission adopted
20 Resolution No. 99 - 078, authorizing the Director of Public Transportation to execute an
21 agreement with BART concerning the FY1998-1999 transfer payment from BART to MUNI;

WHEREAS, The Board of Supervisors has reviewed the proposed agreement, and determined that BART's annual payment to MUNI increases MUNI's ability to provide feeder bus transit service to BART stations, thus encouraging transit use and benefiting patrons of both BART and MUNI; now, therefore be it

RESOLVED, That the Board of Supervisors hereby authorizes the General Manager of Public Transportation to execute the attached Agreement with BART to effect the FY 1998-1999 payment from BART to MUNI.
