
Subject: File No. 240630. Hearing to consider the Department of Public Health's budget reducing medical and health care services provided by the City and County of San Francisco for Fiscal Years (FYs) 2024-2025 and 2025-2026, pursuant to California Health and Safety Code, Section 1442.5(a) (The Beilenson Act).

At this hearing, the Board of Supervisors of the City and County of San Francisco will consider the impacts of the proposed reduction of medical services provided by City and County of San Francisco facilities. Public testimony, both oral and written, will be accepted at this hearing.

The San Francisco Department of Public Health has prepared the attached list of proposed budget reductions that are subject to a Beilenson Hearing, which includes the reduction of medical services at City and County of San Francisco facilities. Although Health and Safety Code, Section 1442.5(a), only requires notice for reductions of medical services at county facilities and does not require notice for reduction of health education, prevention, and outreach services, the Department of Public Health has included proposed changes for both types in the attached list. Only the items in the first section of the list are required to be included in the hearing, but all items will be considered at the hearing regardless. Further information on the proposed reductions is available by telephoning the Department of Public Health at (415) 554-2600.

In accordance with Administrative Code, Section 67.7-1, persons who are unable to attend the hearing on this matter may submit written comments up until the hearing ends. These comments will be made as part of the official public record in this matter and shall be brought to the attention of the Board of Supervisors. 



Sugary Drink Distributors Tax Contract Reductions

The proposed budget for the Department of Public Health (DPH) will shift the City's allocation of funds from the sugary-drink distributors tax ("soda tax") to increase investment in direct food security programs. The plan results in about a \$2.7 million a year in reduction to the chronic disease prevention, urban farming, health education, oral health outreach, and healthy living programs administered by PHD and Primary Care staff.

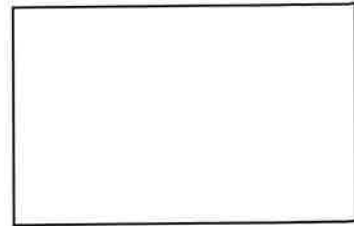
