3 Ordinance authorizing settlement of the lawsuit filed by San Franciscans for Livable  
4 Neighborhoods against the City and County of San Francisco for \$141,692.50 for  
5 attorneys' fees; the lawsuit was filed on November 30, 2004 in San Francisco Superior  
6 Court, Case No. 504-780; entitled San Franciscans for Livable Neighborhoods v. City  
7 and County of San Francisco, et al.; other material terms of said settlement are that  
8 payment is to be made in two equal installments, one in calendar year 2010, one in  
9 calendar year 2011.

11 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. The City Attorney is hereby authorized to settle the action entitled San  
13 Franciscans for Livable Neighborhoods v. City and County of San Francisco, et al., San  
14 Francisco Superior Court, Case No. 504-780 by the payment of attorneys' fees in the amount  
15 of \$141,692.50. In addition, payment is to be made in two equal installments, the first  
16 installment in calendar year 2010, and the second installment in calendar year 2011.
