6 WHEREAS, United Against Hate Week emerged from a United Against Hate poster
7 campaign created by Bay Area cities in response to white supremacist rallies in Berkeley and
8 San Francisco in 2017; and

9 WHEREAS, United Against Hate Week is an annual event aimed at promoting unity,
10 understanding, and the rejection of hate and discrimination with events such as facilitated
11 anti-bias training, how to be an ally training, bystander training, practicing standing up to
12 bigoted remarks or hate speech, in person or online; and

13 WHEREAS, United Against Hate Week, scheduled for September 21 through
14 September 27, 2024, kicks off on International Day of Peace; and

15 WHEREAS, United Against Hate Week provides an opportunity for San Franciscans to
16 join Californians across the state to stand against hate and bigotry, and to celebrate our
17 shared commitment to inclusion and acceptance; and

18 WHEREAS, Dozens of California cities and counties are participating through rallies,
19 community campaigns and public events such as unity walks, film screenings, and panel
20 discussions; and

21 WHEREAS, Members of the public can participate by displaying United Against Hate
22 posters, joining an anti-hate walk or working with local professors, community leaders, and
23 subject matter experts to organize a teach-in on a topic that is relevant to United Against Hate
24 Week; and

1 WHEREAS, The Board of Supervisors of the City and County of San Francisco hereby
2 recognizes United Against Hate Week, to be held September 21 through September 27, 2024;

4 WHEREAS, The City and County of San Francisco encourages residents, businesses,

6 organizing and attending events that promote unity and understanding; and

7 WHEREAS, The City and County of San Francisco reaffirms its dedication to the
8 principles of diversity, inclusion, and respect for all, and condemns all forms of hate and
9 discrimination; and




