10 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. The San Francisco Administrative Code is hereby amended by amending  
13 Section 8.37, to read as follows:

15 **SEC. 8.37. CLERK OF THE BOARD OF SUPERVISORS - FEES.**

(a) The Clerk of the Board of Supervisors is hereby authorized to charge and  
17 collect fees to defray the cost of the issuance of the following specific documents and the  
18 providing of the following services and any persons requesting such documents or services  
19 shall pay the following fee:

14 governmental agencies, or the inability of the requesting person to pay for the requested  
15 service.

17 (c) Each of the fees listed above shall be adjusted annually to reflect  
18 changes in the Consumer Price Index, as determined by the Controller, and shall be rounded  
19 to the nearest whole dollar.


