What is the Technology Marketplace?

- The Technology Marketplace consists of a **pool of suppliers** from whom City can purchase **technology products and services**, including software licenses, computer hardware, configuration/integration services, and software maintenance/support.
- It **originated in the 1990's** as an efficient purchasing model and **can reduce the time required to complete a transaction** from several months to 1-2 weeks.
- Since its inception, the Technology Marketplace has **expanded from a handful of suppliers to more than 50** in its most recent iteration.

- The RFP for the most recent iteration of the Technology Marketplace was issued on August 21, 2023.
- Awards were made as follows:
 1. 10 contracts with initial NTE amounts of \$20 million each.
 2. 44 contracts with initial NTE amounts of \$9 million each.
 3. 37 Micro LBE Set Aside contracts with NTE amounts of \$200,00 each.

- o **61 suppliers**, including 27 Micro LBEs .
- o **As-needed contracts** available to all City departments to purchase technology goods and services based on departments' business needs.
- o All transactions **capped at \$2.5 million**.
- o **Competitive solicitations required** for all transactions above established thresholds.
- o **18% LBE subcontracting requirement** on services.
- o **Administered by OCA** who ensures all City requirements are satisfied by each purchase.

- 1. Provides an Efficient Process for Procuring Essential Hardware, Software, Support, and Services**
 - Reduces procurement time from months to weeks, thereby saving City staff resources and time.
- 2. Increases Competition**
 - Requires transactions above established thresholds to be competitively solicited among 61 suppliers.
- 3. Increases Opportunities for LBEs**
 - 27 prime LBEs that can use their LBE rating bonus/discount against Non-LBE suppliers
 - LBE subcontracting requirements increased from 15% to 18% compared to previous Tech Marketplace.
 - 37 Micro LBE Set Aside contracts.

- Authorize the Office of Contract Administration to enter into an as-needed contract with the ten (10) aforementioned Contractors for the purchase of as-needed technology products and specialized services with a contract not-to-exceed (NTE) amount of \$20 million and a total contract duration of five years.
