11 Housing Code for buildings; and

12 WHEREAS, California Health and Safety Code Section 17958.5 requires the City to  
13 furnish to the California Building Standards Commission reasons for amending the State  
14 Housing code based upon local conditions; and,

15 WHEREAS, A specific section by section statement of the reasons for each  
16 amendment is set forth in that certain document in the Board of Supervisor's file No. 021206  
17 \_\_\_\_\_ identified therein and hereinafter referred to as Exhibit A; and

18 WHEREAS, The Board of Supervisors has reviewed the statement of reasons set forth  
19 for each amendment in said Exhibit A; and

20 WHEREAS, The Board of Supervisors finds and determines that these differences in  
21 the San Francisco Housing Code are necessary because of local conditions for the reasons  
22 set forth in Exhibit A; now therefore be it

23 **RESOLVED, That the Board of Supervisors does hereby find and determine that**  
24 **the aforesaid changes to the San Francisco Housing Code are necessary because of local**  
25 **conditions for the reasons set forth in Exhibit A; and be it**
