10	Be it ordained by the People of the City and County of San Francisco:

12	Section 1. Chapter 20 of the Administrative Code is hereby amended by revising
13	Article XII, Section 20.310, to read as follows:
14	SEC. 20.310. SUNSET.
15	Unless extended by ordinance, this Article XII shall expire by operation of law, and
16	the Committee shall terminate, on July 1, 2022 2027. After the expiration of the Committee, the
17	City Attorney shall cause this Article to be removed from the Administrative Code.
18	
19	Section 2. Effective Date; Retroactivity.
20	(a) This ordinance shall become effective 30 days after enactment. Enactment occurs
21	when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not
22	sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the
23	Mayor's veto of the ordinance.

1 (b) If the effective date of this ordinance is after July 1, 2022, the ordinance shall be 2 retroactive to July 1, 2022, with the intended result that the Shelter Monitoring Committee may 3 continue its operations uninterrupted.

5 Section 3. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors 6 intends to amend only those words, phrases, paragraphs, subsections, sections, articles, 7 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal 8 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment additions, and Board amendment deletions in accordance with the "Note" that appears under 9 10 the official title of the ordinance.

# **Overview of the Shelter Monitoring Committee (SMC)**

- The Shelter Monitoring Committee (SMC) is scheduled to sunset on 7/1/2022.
- We are seeking Board approval to extend the Committee's mandate through 7/1/2027.
- Legislation was developed in collaboration with and is supported by Committee Members.

## **Overview of the Shelter Monitoring Committee**

- SMC established in 2004 to give government agencies and the general public information about city-funded shelters.
- SMC monitors sites to verify that they are meeting 32 Standards of Care. This is done by making announced and unannounced visits, as well as by investigating complaints.
- SMC recommends training, as well as safety, health and other protocol changes, to ensure that clients are treated equally, with dignity and respect.

# Shelter Monitoring Committee - Extension

- In 2020, due to COVID, SMC was dormant for several months. The Board of Supervisors extended the Committee's sunset date from 12/31/20 to July 1, 2022. At this time, we are seeking another extension: to July 1, 2027.
- The Committee has been holding regular public meetings. DPH asked volunteers to hold off on any visits to keep them and shelter guests safe; however, staff (two DPH employees) have been doing inspections, taking complaints, and conducting investigations.
- Volunteers were recently given the okay to return to doing onsite inspections.
- Some changes to the 32 Standards of Care have been tentatively approved by the Committee.
- HSH is interested in having Navigation Centers monitored. Plans are being formulated to accomplish this.
