## Contract History

#### Original Contract:

- **■** Competitive Solicitation Process
- November 16, 2007

#### Contract Purpose:

- Software License, Maintenance and Support
- City's uses Oracle PeopleSoft <u>HR System</u>
- To pay 30,000+ employees, to manage 110,000+ beneficiaries

#### **Amendments:**

- 9 Previous, Done Annually
- Proposed Amendment #10 ... <u>5-Year Extension</u>
- Updated User Support Pricing, User Counts



## Proposed Amendment #10

- Current Support Services expires April 22, 2016
- Amendment #10 extends thru April 2021
- **Software Support Services includes:** 
  - Break/fix support: if software doesn't work, Oracle fixes it
  - Upgrades and new functionality, latest software versions
  - Security Patches
- Total Cost: \$4.3 million over 5 years
- \$860K annually



# Estimated \$266k Savings vs. Alternative

- Without a multi-year agreement?
- Oracle's standard inflationary adjustment applies.
- **■** Between 3-4%.
- Proposed Amendment #10 locks in next 5 years.
- **Estimated <u>\$265k savings</u>**.
