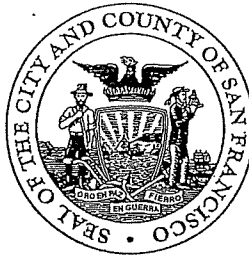

13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. The Business and Tax Regulations Code is hereby amended by adding
15 Section 6.15-4 to Article 6, to read as follows:

16 SEC. 6.15-4. VALIDATION ACTIONS; STATUTE OF REPOSE.

17 (a) Chapter 9 (commencing with Section 860) of Title 10 of Part 2 of the California Code of
18 Civil Procedure applies to any judicial action or proceeding to validate, attack, review, set aside, void,
19 or annul Propositions C and/or G, adopted by San Francisco voters on June 5, 2018.


20 (b) For purposes of this Section 6.15-4, Propositions C and G, adopted by San Francisco
21 voters on June 5, 2018, shall be deemed to have been adopted on the effective date of this Section for
22 purposes of determining the limitations period in Section 860 of the California Code of Civil
23 Procedure.

24 (c) Any appeal from the final judgment in an action or proceeding brought under Section 6.15-
25 4(a) shall be filed within 30 days after entry of the judgment.

1 Section 2. Effective Date. This ordinance shall become effective 30 days after
2 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
3 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
4 of Supervisors overrides the Mayor's veto of the ordinance.


