2 Ordinance adopting and implementing an amendment to the 2001-2003 Collective
3 Bargaining Agreement between the City and County of San Francisco and the Glaziers,
4 Architectural Metal and Glass Workers, Local 718, by appending a Letter of Agreement
5 concerning the City's 2002-2003 budget which provides: (a) for the City to reduce its
6 "pick-up" of the required employee contribution to the retirement system by 2.75% of

13 Section 1. The Board of Supervisors hereby adopts and implements an amendment
14 to the 2001-2003 Collective Bargaining Agreement between the City and County of San
15 Francisco and the Glaziers, Architectural Metal and Glass Workers, Local 718, by appending
16 a Letter of Agreement concerning the City's 2002-2003 budget which provides: (a) for the
17 City to reduce its "pick-up" of the required employee contribution to the retirement system by
18 2.75% of the employees' compensation effective July 1, 2002 through June 30, 2003; (b) a
19 1% base wage increase effective close of business June 30, 2003 and; (c) a no layoff
20 commitment in fiscal year 2002-2003 for employees represented by participating employee
21 organizations.




