3 **Ordinance authorizing the service of an Offer To Compromise under Code of Civil**
4 **Procedure, Section 998 in the lawsuit filed by Michael Christopher Daniel against**
5 **Emrulkayes Akter and the City and County of San Francisco for up to \$350,000; the**
6 **lawsuit was filed on May 18, 2022, in Alameda Superior Court, Case No. 22-cv-011434,**
7 **and transferred by stipulation on December 30, 2022, to Contra Costa Superior Court,**
8 **Case No. C23-00311; entitled Michael Christopher Daniel v. Emrulkayes Akter, et al.; the**
9 **lawsuit involves alleged personal injuries arising from a collision between a City-**
10 **owned vehicle and a pedestrian.**

12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. The City Attorney is hereby authorized to settle the action entitled Michael
14 Christopher v. Emrulkayes Akter, et al., Contra Costa Superior Court, Case No. C23-00311 by
15 the payment of up to \$350,000 and judgment to be entered only against the City and County
16 of San Francisco in that amount. The lawsuit involves alleged personal injuries arising from a
17 collision between a City-owned vehicle and a pedestrian.

18 Section 2. The above-named action was filed in Alameda Superior Court on May 18,
19 2022 and transferred by stipulation to Contra Costa Superior Court on December 30, 2022,
20 and the following parties were named in the lawsuit: Plaintiff Michael Christopher; Defendants
21 Emrulkayes Akter, City of San Francisco, and County of San Francisco.
