3 **Resolution authorizing the Department of the Environment to apply for annual grants**
4 **from the California Integrated Waste Management Board for the purpose of increasing**
5 **Used Motor Oil Recycling and Household Hazardous Waste Management.**

7 WHEREAS, the people of the State of California have enacted the California Oil
8 Recycling Enhancement Act that provides funds to cities and counties for establishing and
9 maintaining local used oil collection programs that encourage recycling or appropriate
10 disposal of used oil; and,

11 WHEREAS, the people of the State of California have enacted Assembly Bill 1220
12 (Eastin, Statues of 1993, Chapter 656) that provides grants to local governments to establish
13 and implement waste diversion and separation programs to prevent disposal of hazardous
14 waste, including household hazardous waste, in solid waste landfills; and.

15 WHEREAS, the California Integrated Waste Management Board has been delegated
16 the responsibility for the administration of the program within the state, setting up necessary
17 procedures governing application by cities and counties under the program; and,

18 WHEREAS, if awarded a grant, the applicant will enter into a Grant Agreement with the
19 California Integrated Waste Management Board for implementation of said grants; now,
20 therefore, be it

21 RESOLVED that the City and County of San Francisco authorizes the submittal of
22 grant applications to the California Integrated Waste Management Board for all available
23 California Oil Recycling Grants and all available Household Hazardous Waste Grants for the
24 period of FY 2005/2006 to FY 2008/2009.
