3 **Ordinance authorizing settlement of the lawsuit filed by Landis Smith against the City**
4 **and County of San Francisco for \$225,000; the lawsuit was filed on April 4, 2024, in San**
5 **Francisco Superior Court, Case No. CGC-24-613660; entitled Landis Smith v. City and**
6 **County of San Francisco, et al.; the lawsuit involves alleged personal injury on a City**
7 **sidewalk.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Landis Smith v. City and County of
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC-24-613660 by the
13 payment of \$225,000. The lawsuit involves alleged personal injury on a City sidewalk.

14 Section 2. The above-named action was filed in San Francisco Superior Court on April
15 4, 2024, and the following parties were named in the lawsuit: Plaintiff Landis Smith;
16 Defendants City and County of San Francisco, Walgreens, Melvin Dagovitz and Angela
17 Dagovitz.
