The project includes demolition of the 40-year-old, 18-gate Boarding Area B facility, and the construction of a new Boarding Area B facility of approximately 560,000 square feet with 28-gates configuration.

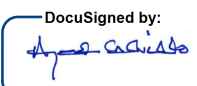
